HOUSE AMENDMENT "A" to H.P. 1187, L.D. 1615, Bill, "An Act To Amend the Election Laws"

Amend the bill by inserting after section 11 the following:

Sec. 12. 30-A MRSA §66-B, sub-§1, as corrected by RR 2013, c. 1, §47, is amended to read:

1. Creation of Androscoggin County Commissioner Districts. Androscoggin County is divided into the following 7 districts.

A. 35 every 4 years thereafter.'

37 section number to read consecutively.
