HOUSE AMENDMENT "A" to S.P. 662, L.D. 1667, Bill, "An Act To Amend Certain Provisions of Inland Fisheries and Wildlife Laws"

Amend the bill by inserting after section 12 the following:

'Sec. 13. PL 2013, c. 368, Pt. YY, §1 is amended to read:

Sec. YY-1. Transfer of funds from Carrying Balances - Inland Fisheries and Wildlife, General Fund account. Notwithstanding any other provision of law, the State Controller shall transfer \$150,000 on or before August 1, 2013 from the Carrying Balances - Inland Fisheries and Wildlife, General Fund account to the Administrative Services - Inland Fisheries and Wildlife, General Fund account to fund security improvements and renovations at the Gray headquarters facility the construction of a new headquarters facility in Gray.

SUMMARY

Public Law 2013, chapter 368 authorized the transfer of \$150,000 to fund security improvements and renovations at the Gray headquarters facility. This amendment instead authorizes the funds to be used for the construction of a new headquarters facility in Gray.

The amendment changes the purpose of a \$150,000 transfer that was made on or before August 1, 2013 from the Inland Fisheries and Wildlife - Carrying Account to the Administrative Services account within the Department of Inland Fisheries and Wildlife. The original purpose of the transfer was for security improvements and renovations at the current Gray headquarters facility. The new purpose is for construction of a new headquarters facility in Gray. It is not currently known how the original purposes for the use of the money will be met.
