1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3 **Whereas,** services contracted for by the Office of the Attorney General need to be
4 paid for prior to the end of fiscal year 2013-14, which will likely fall within the 90-day
5 period; and

6 **Whereas,** in the judgment of the Legislature, these facts create an emergency within
7 the meaning of the Constitution of Maine and require the following legislation as
8 immediately necessary for the preservation of the public peace, health and safety; now,
9 therefore,

10 **Be it enacted by the People of the State of Maine as follows:**

11 **Sec. 1. Appropriations and allocations.** The following appropriations and
12 allocations are made.

13 **ATTORNEY GENERAL, DEPARTMENT OF THE**

14 **Administration - Attorney General 0310**

15 Initiative: Establishes one Research Assistant position to function as a trial preparation
16 assistant in the Criminal Division.

12 **Emergency clause.** In view of the emergency cited in the preamble, this
13 legislation takes effect when approved.

14 **SUMMARY**

15 This bill funds a position within the Office of the Attorney General as well as a
16 part-time position to serve as the Domestic Abuse Homicide Review Panel Coordinator.
17 Additionally, this bill appropriates funds necessary to allow the Office of the Chief
18 Medical Examiner to provide for statutorily authorized payments to medical examiners,
19 reimbursement to funeral homes and funds for contracted forensic pathologist services
20 necessary for the operation of the office.
