COMMITTEE AMENDMENT "B" to S.P. 730, L.D. 1824, Bill, "An Act To Provide Additional Authority to the State Board of Corrections"

Amend the bill by inserting after the title and before the enacting clause the following:

'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the State Board of Corrections is not functioning as intended by the Legislature to provide a coordinated county jail system; and

Whereas, this legislation is necessary to address the improper functioning as soon as possible; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'

Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:

'Sec. 1. 4 MRSA §1057, sub-§3-A, as amended by PL 2009, c. 213, Pt. GGG, §1 and affected by §7, is further amended to read:

3-A. Reimbursement to counties. Monthly, the Treasurer of State shall transfer funds from the Government Operations Surcharge Fund to the State Board of Corrections ~~Investment~~ Operational Support Fund program in an amount equal to 2% of the total fines, forfeitures and penalties, including the surcharge imposed pursuant to subsection 2-A, received by the Treasurer of State for deposit in the Government Operations Surcharge Fund. The balance remaining in the Government Operations Surcharge Fund at the end of each month must accrue to the General Fund. Funds collected and deposited each month to the Government Operations Surcharge Fund must be transferred on the last

1 day of the month in which the collections are made to the State Board of Corrections

3 At the close of each month, the State Controller shall calculate the amount to be

33 **5. Report by chair of the State Board of Corrections.** The chair of the board shall
34 report at least annually on or before the 2nd Friday in December to the joint standing
35 committee of the Legislature having jurisdiction over appropriations and financial affairs

40 contracts between the board and the counties. The contracts may provide for the use of

1 state funds, board and county responsibilities and any other provisions the board
2 determines necessary.

3 **§1809. Application for other funds**

4 The board may accept funds and apply for grants and other funds to implement
5 statewide or multicounty corrections initiatives, including, but not limited to,
6 programming, technology, innovation and other initiatives to create a statewide county
7 jail system.

8 **§1810. Budget format**

9 **1. Creation of the county budget.** The board shall develop and implement a budget
10 format for county jails and a budget process that follows the same format and process that
11 the State Budget Officer uses for the General Fund budget and for the department.

12 **2. Baseline budget and budget initiatives.** The board shall create a baseline budget
13 for funding the county jails and new funding initiatives that define the need for funding
14 decreases or increases. The board shall transmit budget instructions from the Department
15 of Administrative and Financial Services to the county commissioners, who shall submit
16 the budgets for their respective counties to the board. The budget instructions must
17 include a budget growth factor consistent with the provisions of Title 30-A, section 710,
18 subsection 1-A that the Department of Administrative and Financial Services has
19 approved.

20 **3. Single chart of accounts.** The board shall establish a single chart of accounts for
21 county corrections-related expenditures consistent with state General Fund standards and
22 practices. All county jail budgets must be based and submitted on a state fiscal year
23 basis.

24 **4. Standardized format and data.** The board shall adopt rules with respect to the
25 standardized format and data to be used in county jail budgets and record keeping. The
26 board shall ensure consistency in all county jail budgets to facilitate comparisons among
27 county budgets and benchmarking.

28 **5. Funding allocation among county jails.** The board shall develop and approve a
29 formula for allocating funding to the county jails. In determining the funding allocation
30 formula, the board shall adopt rules that include, but are not limited to, rules regarding:

- 31 A. Jail size;
32 B. The number of beds;
33 C. The age of a facility;
34 D. Historic costs;
35 E. Management information system upgrades; and
36 F. Any other criteria determined necessary by the board.

37 **§1811. County Corrections Capital Improvement Fund**

38 **1. Fund established.** The County Corrections Capital Improvement Fund, referred
39 to in this section as "the fund," is established.

1 **2. Capital investment plan; capital expenditure budget.** The board shall prepare a
2 10-year system-wide capital investment plan to be used to determine capital projects that
3 can be funded for each county jail facility from the fund. The board shall report on the
4 status of the capital investment plan to the Legislature by no later than January 15th of
5 each first regular session of the Legislature. The board shall contract with an independent
6 entity with expertise in developing a capital investment plan for correctional facilities to
7 assist in developing the plan.

8 The board shall develop a capital expenditure budget for each county jail facility based on
9 the capital investment plan to be submitted by each county with the operational budget
10 for inclusion in the biennial budget or as required by the State Budget Officer.

11 **3. Budget growth factor.** The capital expenditure budget under subsection 2 must
12 include a budget growth factor pursuant to Title 30-A, section 710, subsection 1-A that is
13 approved by the Department of Administrative and Financial Services.

14 **4. Rules.** The board shall adopt rules governing the capital expenditure budget that
15 take into consideration but are not limited to the following:

16 A. The age of the county jail facility;

17 B. The condition of the county jail facility;

18 C. Inmate and employee safety;

19 D. The needs of the system-wide correctional system;

20 E. Improvements necessary for the county jail facility to be more efficient; and

21 F. Any other criteria the board determines necessary.

22 **5. Verification of emergency capital requests.** In cases of emergency, if there are
23 insufficient funds in the fund and in the retained funds of the affected county, the board
24 may approve transfer of funds from the State Board of Corrections Operational Support
25 Fund program. The board shall verify emergency capital requests based on criteria
26 established by the board. The board shall:

27 A. Develop a uniform request form;

28 B. Require backup information documenting the emergency; and

29 C. Require evidence that the county used the most efficient procurement process
30 possible under the emergency circumstances.

31 **6. Reports to the board.** Any payments made from the State Board of Corrections
32 Operational Support Fund program that are not required to be approved by the board must
33 be reported to the board in advance and included in financial reports on the State Board of
34 Corrections Operational Support Fund program.

35 **§1812. Use of funds**

36 **1. Restriction on use of funds.** Property tax revenues for the support of county jails
37 pursuant to Title 30-A, section 701, subsection 2-A and the State Board of Corrections
38 Operational Support Fund program may be used only for county jail operations.

1 **2. Fund balances.** Fund balances remaining at the end of any fiscal year do not
2 lapse but are carried forward for the benefit of the county jails that created the surplus.

3 **3. Capital funds.** Capital funds appropriated or allocated through the Capital
4 Investment Fund or from other sources may be used only for approved capital investment
5 purposes as determined by the board.

6 **4. Inmate boarding revenues.** Except as provided in this subsection, federal or
7 state inmate boarding revenues are retained by the county jail facility generating the
8 funds and are not offset against the state appropriation otherwise due that county under
9 the approved allocation formula. Federal inmate boarding revenues are retained by the
10 county up to budgeted amounts approved as part of the county correctional services
11 budget procedure pursuant to Title 30-A, section 710 and the remaining federal revenues
12 must be used as follows:

13 A. A county jail holding jail debt on or before July 1, 2008 shall transfer 25% of any
14 remaining federal revenue to the County Corrections Capital Improvement Fund
15 under section 1811 and apply 75% to the jail debt until the full discharge of that debt.

16 B. A county jail without any jail debt must transfer 75% of any remaining federal
17 revenues to the County Corrections Capital Improvement Fund under section 1811.

18 **5. Allocation of funds on quarterly basis.** The board shall distribute allotments of
19 funds quarterly, together with a report of the financial status of each county jail facility.
20 The board may curtail funds as necessary to address shortfalls. The board may request
21 the State Budget Officer to transfer funds from one quarter to another to meet the needs
22 of county jails.

23 **6. Revenue and expenditure reports.** A county jail facility shall send a report of
24 revenues generated and expenses incurred by the county jail to the board on a monthly
25 basis and in the format prescribed by the board.

26 **§1813. Monitoring performance**

27 The board may monitor the operational, programmatic and financial performance of
28 each county jail facility and establish appropriate metrics and data collection
29 requirements to compare the counties among themselves and with other appropriate
30 jurisdictions. The board shall require timely reporting of the data collected in a consistent
31 format.

32 **§1814. Enforcement authority**

33 **1. Board actions.** A county jail that violates a provision of this subchapter may be
34 subject to the following as determined by the board:

35 A. Holding in escrow appropriations otherwise due to a county jail;

36 B. Making a county jail facility ineligible for participation in programs;

37 C. Suspending or denying funding;

38 D. Requiring a county jail to transfer funds collected pursuant to Title 30-A, section
39 701, subsection 2-A to the State Controller to be credited to the State Board of

1 Corrections Operational Support Fund program in an amount sufficient to cover any
2 sums due to the board, the state or the other counties; and

3 E. If the county jail facility is a habitual violator, restricting or modifying the
4 operations of the county jail facility and making a request to the department to take
5 over the management and control of the county jail facility and its staff and inmates.
6 For purposes of this paragraph, "habitual violator" means a county jail facility with 3
7 or more violations of this subchapter. The board shall adopt rules to implement the
8 provisions of this paragraph. Rules adopted pursuant to this paragraph are major
9 substantive rules as defined in Title 5, chapter 375, subchapter 2-A.

10 A county that violates this subchapter is responsible for all costs incurred by the State or
11 other counties as a result of the violation, and the board may reallocate that county's
12 appropriations during the time the county remains in violation of this subchapter.

13 **2. Withdrawal from correctional system prohibited.** A sheriff or a county
14 commissioner may not withdraw a county jail facility from the coordinated correctional
15 system or refuse to house any out-of-county inmates except in cases of jail overcrowding
16 as determined by the department. Any disagreement or dispute by a county with the board
17 is subject to mediation proceedings developed pursuant to this subchapter. This
18 subsection does not prohibit a party from petitioning a court for relief at any time.

19 For purposes of this section, a violation of this subchapter includes a violation of a
20 rule adopted by the board pursuant to this subchapter.

21 **§1815. Program incentives**

22 The board may provide funding to a county to support innovative or efficient
23 programs for meeting needs of a county jail facility identified by the county or the board.

24 **Sec. 28. Use of electronic technology.** The State Board of Corrections shall
25 work with the judicial branch to use electronic technology whenever possible to reduce
26 the level of physical transfer of inmates between a county jail facility and a court. The
27 board shall report its progress on the use of electronic technology to the joint standing
28 committee of the Legislature having jurisdiction over criminal justice and public safety
29 matters by February 28, 2015.

30 **Sec. 29. Rename program; State Board of Corrections.** Notwithstanding
31 any other provision of law, the State Board of Corrections Investment Fund program
32 within the State Board of Corrections is renamed the State Board of Corrections
33 Operational Support Fund program.

34 **Sec. 30. Appointment of members to the State Board of Corrections;**
35 **transitional members of board.** Members for the 5 positions on the State Board of
36 Corrections as described in the Maine Revised Statutes, Title 34-A, section 1802,
37 subsection 1 must be appointed as provided in Title 34-A, section 1802, subsection 1.
38 Notwithstanding Title 34-A, section 1802, on the effective date of this Act, the State
39 Board of Corrections consists of the following 5 members:

- 40 1. The most recently appointed member representing sheriffs;
41 2. The most recently appointed member representing county commissioners;
42 3. The 2 members representing the executive branch; and

1 4. The most recently appointed member representing the public.

2 The 5 members of the State Board of Corrections on the effective date of this Act as
 3 described in subsections 1 to 4 may remain on the State Board of Corrections until the
 4 member or the member's successor is appointed and confirmed.

5 **Sec. 31. Appropriations and allocations.** The following appropriations and
 6 allocations are made.

4 analyst to assist the State Board of Corrections.

5 11. It provides that a county may exceed the budget growth factor as applied to
6 personnel costs but may not exceed the county's overall budgeted growth factor cap.

21 and services, including, but not limited to, motor vehicles, information technologies and
22 office equipment, that do not exceed \$50,000 per item.

23 17. It provides that in the first fiscal year in which any unencumbered balance in the
24 corrections-related account of a county arises out of savings realized during the course of
25 that fiscal year, the county may retain the unencumbered balance for future corrections-
26 related purposes; however, 10% of savings in any subsequent fiscal year must be
27 submitted to the State Board of Corrections.

28 18. It creates the County Corrections Capital Improvement Fund and requires the
29 State Board of Corrections to prepare a 10-year system-wide capital investment plan with
30 the assistance of an independent entity for the purpose of determining capital projects that
31 can be funded for each county jail facility from the fund.

32 19. It directs the State Board of Corrections to contract with an independent entity
33 with expertise in developing a capital investment plan for correctional facilities to assist
34 in developing the 10-year system-wide capital investment plan.

35 20. It requires the State Board of Corrections to report on the status of a capital
36 investment plan to the Legislature by no later than January 15th of each first regular
37 session of the Legislature.

38 21. It requires the State Board of Corrections to develop a capital expenditure budget
39 for each county jail facility based on a capital investment plan to be submitted by each
40 county with the operational budget for inclusion in the biennial budget or as required by
41 the State Budget Officer.

Fiscal Detail and Notes

This bill includes a one-time General Fund appropriation of \$1,200,000 in fiscal year 2013-14 to the State Board of Corrections to address an anticipated shortfall and a one-time appropriation of \$225,000 in fiscal year 2014-15 for the development of an independent system-wide capital improvement plan. It does not address supplemental funding needs in fiscal year 2014-15. It establishes a budget growth factor that will likely increase the state share of county jail costs. The value of the growth factor using estimated fiscal year 2012-1013 and fiscal year 2013-14 data exceeds \$1,900,000. The exact amount required will vary each year.

This bill allows counties to retain savings realized during the course of the fiscal year rather than returning the funds to the State Board of Corrections and may increase the amount of General Fund appropriations required in any given fiscal year. It also allows counties to retain funds received from boarding federal or state inmates. These funds are to be used to discharge debt and as a source of funds to establish a County Corrections Capital Improvement Fund. These revenues had been available to reduce the amount of state funding needed to support county jail operational costs.

This bill also authorizes an increase in the county tax levy for correctional services based on the consumer price index. An increase of 1.37% would result in an increase of \$851,761. The exact amount of the increase will vary every year.
