Amend the resolve by adding after section 5 the following:

'Sec. 6. Appropriations and allocations. Resolved: That the following appropriations and allocations are made.

Fiscal Detail and Notes

The Department of Administrative and Financial Services has identified the need for additional General Fund appropriations for 5 positions and associated costs to implement recommendations of the Government Oversight Committee related to ethics practices and procedures for executive branch employees. The bill includes appropriations of \$495,307 in fiscal year 2015-16 and \$660,697 in fiscal year 2016-17.

Any additional costs to the Commission on Governmental Ethics and Election practices are expected to be minor and can be absorbed within existing budgeted resources.
