

1 Be it enacted by the People of the State of Maine as follows:

2 Sec. 1. 1 MRSA c. 25, sub-c. 3 is enacted to read:

3 **SUBCHAPTER 3**

4 **GUBERNATORIAL TRANSITION**

5 **§1051. Gubernatorial transition committee**

6 **1. Definitions.** As used in this subchapter, unless the context otherwise indicates,  
7 the following terms have the following meanings.

8 A. "Commission" means the Commission on Governmental Ethics and Election  
9 Practices.

10 B. "Election cycle" means the period beginning on the day after the general election  
11 for any state, county or municipal office and ending on the day of the next general  
12 election for that office.

13 **2. Transition and inaugural activities; funding.** A person may solicit and accept  
14 donations for the purpose of financing costs related to the transition to office and  
15 inauguration of a new Governor. A person who accepts donations for these purposes  
16 must establish a committee and appoint a treasurer who is responsible for keeping records  
17 of donations and for filing a financial disclosure statement required by this section. All  
18 donations received must be deposited in a separate and segregated account and may not  
19 be commingled with any contributions received by any candidate or political committee  
20 or any personal or business funds of any person. An individual who has served as a  
21 treasurer of any candidate committee or political action committee in the same election  
22 cycle may not serve as treasurer of a gubernatorial transition committee.

23 **3. Registration with the commission and financial disclosure statement.** A  
24 committee established pursuant to this section shall register and file a financial disclosure  
25 statement with the commission as required by this subsection.

26 A. The committee shall register with the commission within 10 days after  
27 appointment of a treasurer. The registration must include the name and mailing  
28 addresses of the members of the committee, its treasurer and all individuals who are  
29 raising funds for the committee.

30 B. The financial disclosure statement must contain the names, addresses, occupations  
31 and employers of all donors who have given money or anything of value in a total  
32 amount exceeding \$50 to the committee, including in-kind donations of goods or  
33 services, along with the amounts and dates of the donations. Donors who have given  
34 donations with a total value of \$50 or less may be disclosed in the aggregate without  
35 itemization or other identification.

36 C. Any outstanding loan, debt or other obligation of the committee must be disclosed  
37 as a donation.

1           D. The financial disclosure statement must identify the amounts, dates, payees and  
2           purposes of all payments made by the committee.

3           E. An interim financial disclosure statement must be filed by 5:00 p.m. on January  
4           1st following the gubernatorial election and must be complete as of 10 days prior to  
5           that date. The final financial disclosure statement must be filed by 5:00 p.m. on  
6           February 15th following the gubernatorial election and must be complete as of that  
7           date.

8           **4. Limitation on fund-raising activity.** A committee established pursuant to this  
9           section may accept donations until January 31st of the year following the gubernatorial  
10           election.

11           **5. Prohibited donations during a legislative session.** A committee established  
12           pursuant to this section may not directly or indirectly solicit or accept a donation from a  
13           lobbyist, lobbyist associate or employer during any period of time in which the  
14           Legislature is convened before final adjournment. A lobbyist, lobbyist associate or  
15           employer may not directly or indirectly give, offer or promise a donation to a committee  
16           established pursuant to this section during any period of time in which the Legislature is  
17           convened before final adjournment.

18           **6. Anonymous donations.** A committee established pursuant to this section may not  
19           accept an anonymous donation in excess of \$50.

20           **7. Disposing of surplus funds.** Prior to the filing of the final financial disclosure  
21           statement under subsection 3, paragraph E, any surplus funds remaining in the  
22           committee's account must be refunded to one or more donors, donated to a charitable  
23           organization that qualifies as a tax-exempt organization under 26 United States Code,  
24           Section 501(c)(3) or remitted to the State Treasurer.

25           **8. Rulemaking.** The commission may establish by routine technical rule, adopted in  
26           accordance with Title 5, chapter 375, subchapter 2-A, forms and procedures for ensuring  
27           compliance with this section.

28           **9. Enforcement and penalty.** The commission shall administer and enforce this  
29           subchapter. A person who violates this subchapter is subject to a civil penalty not to  
30           exceed \$10,000, payable to the State and recoverable in a civil action.

31           **Sec. 2. 21-A MRSA §1004-C** is enacted to read:

32           **§1004-C. Enhanced penalties for violations with aggravating circumstances**

33           Notwithstanding any maximum penalty otherwise set forth in this chapter, when  
34           assessing a penalty or monetary sanction, the commission may double the authorized  
35           penalty or monetary sanction for a violation occurring less than 28 days prior to an  
36           election day and may triple the authorized penalty or monetary sanction for a violation  
37           occurring less than 14 days prior to an election day.

38           **Sec. 3. 21-A MRSA §1014, sub-§2-B** is enacted to read:

1           **2-B. Top 3 funders; independent expenditures.** A communication that is funded  
2 by an entity making an independent expenditure as defined in section 1019-B, subsection  
3 1 must conspicuously include the following statement:

4           "The top 3 funders of (name of entity that made the independent expenditure) are (names  
5 of top 3 funders)."

6           The information required by this subsection may appear simultaneously with any  
7 statement required by subsection 2 or 2-A. A communication that contains a visual  
8 aspect must include the statement in written text. A communication that does not contain  
9 a visual aspect must include an audible statement. This statement is required only for  
10 communications made through broadcast or cable television, broadcast radio, Internet  
11 audio programming, direct mail or newspaper or other periodical publications.

12           A cable television or broadcast television communication must include both an audible  
13 and a written statement. For a cable television or broadcast television communication 30  
14 seconds or less in duration, the audible statement may be modified to include only the  
15 single top funder.

16           The top funders named in the required statement consist of the funders providing the  
17 highest dollar amount of funding to the entity making the independent expenditure since  
18 the day following the most recent general election day.

19           A. For purposes of this subsection, "funder" includes:

20                   (1) Any entity that has made a contribution as defined in section 1052,  
21 subsection 3 to the entity making the independent expenditure since the day  
22 following the most recent general election day; and

23                   (2) Any entity that has given a gift, subscription, loan, advance or deposit of  
24 money or anything of value, including a promise or agreement to provide money  
25 or anything of value whether or not legally enforceable, except for transactions in  
26 which a fair value is given in return, since the day following the most recent  
27 general election day.

28           B. If funders have given equal amounts, creating a tie in the ranking of the top 3  
29 funders, the tie must be broken by naming the tying funders in chronological order of  
30 the receipt of funding until 3 funders are included in the statement. If the  
31 chronological order cannot be discerned, the entity making the independent  
32 expenditure may choose which of the tying funders to include in the statement. In no  
33 case may a communication be required to include the names of more than 3 funders.

34           C. The statement required under this subsection is not required to include the name  
35 of any funder who has provided less than \$1,000 to the entity making the independent  
36 expenditure since the day following the most recent general election day.

37           D. If only one or 2 funders must be included pursuant to this subsection, the  
38 communication must identify the number of funders as "top funder" or "top 2  
39 funders" as appropriate. If there are no funders required to be included under this  
40 subsection, no statement is required.

41           E. When compiling the list of top funders, an entity making an independent  
42 expenditure may disregard any funds that the entity can show were used for purposes

1 unrelated to the candidate mentioned in the communication on the basis that funds  
2 were either spent in the order received or were strictly segregated in other accounts.

3 F. In any communication consisting of an audio broadcast of 30 seconds or less or a  
4 print communication of 20 square inches or less, the requirements of this subsection  
5 are satisfied by including the name of the single highest funder only.

6 G. If the list of funders changes during the period in which a recurring  
7 communication is aired or published, the statement appearing in the communication  
8 must be updated at the time that any additional payments are made for that  
9 communication.

10 H. The commission may establish by routine technical rule, adopted in accordance  
11 with Title 5, chapter 375, subchapter 2-A, forms and procedures for ensuring  
12 compliance with this subsection. Rules adopted pursuant to this paragraph must  
13 ensure that the information required by this subsection is effectively conveyed for a  
14 sufficient duration and in a sufficient font size or screen size where applicable  
15 without undue burden on the ability of the entity to make the communication. The  
16 rules must also provide an exemption for types of communications for which the  
17 required statement would be impossible or impose an unusual hardship due to the  
18 unique format or medium of the communication.

19 **Sec. 4. 21-A MRSA §1014, sub-§4**, as amended by PL 2011, c. 389, §12, is  
20 further amended to read:

21 **4. Enforcement.** A violation of this section may result in a civil penalty of no more  
22 than ~~\$5,000~~ 100% of the amount of the expenditure in violation, except that an  
23 expenditure for yard signs lacking the required information may result in a maximum  
24 civil penalty of \$200. In assessing a civil penalty, the commission shall consider, among  
25 other things, how widely the communication was disseminated, whether the violation was  
26 intentional, whether the violation occurred as the result of an error by a printer or other  
27 paid vendor and whether the communication conceals or misrepresents the identity of the  
28 person who financed it. If the person who financed the communication or who  
29 committed the violation corrects the violation within 10 days after receiving notification  
30 of the violation from the commission by adding the missing information to the  
31 communication, the commission may decide to assess no civil penalty.

32 **Sec. 5. 21-A MRSA §1019-B, sub-§1, ¶B**, as amended by PL 2013, c. 334, §15,

34 B. Is presumed to be any expenditure made to design, produce or disseminate a  
35 communication that names or depicts a clearly identified candidate and is  
36 disseminated during the ~~24~~ 28 days, including election day, before a primary election;  
37 ~~or during the 35 days, including election day, before a general or special election; or~~  
38 from Labor Day to a general election day.

39 **Sec. 6. 21-A MRSA §1019-B, sub-§4**, as amended by PL 2013, c. 334, §16, is  
40 further amended to read:

41 **4. Report required; content; rules.** A person, party committee, political committee  
42 or political action committee that makes independent expenditures aggregating in excess

1 of \$100 during any one candidate's election shall file a report with the commission. In  
2 the case of a municipal election, the report must be filed with the municipal clerk.

3 A. A report required by this subsection must be filed with the commission according  
4 to a reporting schedule that the commission shall establish by rule that takes into  
5 consideration existing campaign finance reporting requirements. Rules adopted  
6 pursuant to this paragraph are routine technical rules as defined in Title 5, chapter  
7 375, subchapter 2-A.

8 B. A report required by this subsection must contain an itemized account of each  
9 expenditure aggregating in excess of \$100 in any one candidate's election, the date  
10 and purpose of each expenditure and the name of each payee or creditor. The report  
11 must state whether the expenditure is in support of or in opposition to the candidate  
12 and must include, under penalty of perjury, as provided in Title 17-A, section 451, a  
13 statement under oath or affirmation whether the expenditure is made in cooperation,  
14 consultation or concert with, or at the request or suggestion of, the candidate or an  
15 authorized committee or agent of the candidate.

16 C. A report required by this subsection must be on a form prescribed and prepared by  
17 the commission. A person filing this report may use additional pages if necessary,  
18 but the pages must be the same size as the pages of the form. The commission may  
19 adopt procedures requiring the electronic filing of an independent expenditure report,  
20 as long as the commission receives the statement made under oath or affirmation set  
21 out in paragraph B by the filing deadline and the commission adopts an exception for  
22 persons who lack access to the required technology or the technological ability to file  
23 reports electronically. The commission may adopt procedures allowing for the  
24 signed statement to be provisionally filed by facsimile or electronic mail, as long as  
25 the report is not considered complete without the filing of the original signed  
26 statement.

33 **Sec. 8. 21-A MRSA §1020-A, sub-§5-A**, as amended by PL 2011, c. 558, §§4,

35 **5-A. Maximum penalties.** Penalties assessed under this subchapter may not exceed:

36 A. Five thousand dollars for reports required under section 1017, subsection 2,  
37 paragraph B, C, D, E or H; section 1017, subsection 3-A, paragraph B, C, D, D-1 or  
38 F; and section 1017, subsection 4, except that if the financial activity reported late  
39 exceeds \$50,000, the maximum penalty is 100% of the amount reported late;

1 A-1. Five thousand dollars for reports required under section 1019-B, subsection 4,  
2 except that if the financial activity reported late exceeds \$50,000, the maximum  
3 penalty is ~~1/5~~ 100% of the amount reported late;

6 activity reported late exceeds \$50,000, the maximum penalty is ~~1/5~~ 100% of the

10 D. Five hundred dollars for municipal, district and county committees for reports

14 **3. Basis for penalties.** The penalty for late filing of a report required under this  
15 subchapter is a percentage of the total contributions or expenditures for the filing period,  
16 whichever is greater, multiplied by the number of calendar days late, as follows:

17 A. For the first violation, ~~1%~~ 2%;

18 B. For the 2nd violation, ~~3%~~ 4%; and

19 C. For the 3rd and subsequent violations, ~~5%~~ 6%.

20 Any penalty of less than \$10 is waived.

21 Violations accumulate on reports with filing deadlines in a 2-year period that begins on  
22 January 1st of each even-numbered calendar year. Waiver of a penalty does not nullify

28 duly executed report to the commission, as long as an original of the same report is  
29 received by the commission within 5 calendar days thereafter.

4 financial activity not reported, whichever is greater.

7 as a Maine Clean Election Act candidate;

8 E. Fund revenues that were distributed to a Maine Clean Election Act candidate and  
9 that remain unspent after the candidate has lost a primary election or after all general  
10 elections;

11 F. Other unspent fund revenues distributed to any Maine Clean Election Act  
12 candidate who does not remain a candidate throughout a primary or general election  
13 cycle;

14 G. Voluntary donations made directly to the fund; and

15 H. Fines collected under section 1020-A, subsection 4-A and section 1127.

16 ~~**3. Determination of fund amount.** If the commission determines that the fund will~~  
17 ~~not have sufficient revenues to cover the likely demand for funds from the Maine Clean~~  
18 ~~Election Fund in an upcoming election, by January 1st the commission shall provide a~~  
19 ~~report of its projections of the balances in the Maine Clean Election Fund to the~~  
20 ~~Legislature and the Governor. The commission may submit legislation to request~~  
21 ~~additional funding or an advance on revenues to be transferred pursuant to subsection 2,~~  
22 ~~paragraph B.~~

23 **4. Report on fund amount; operating margin.** By January 1st of each year the  
24 commission shall provide to the Legislature and the Governor a report of its projection of  
25 the revenues and expenditures of the Maine Clean Election Fund for the subsequent  
26 4-year period. The commission shall include in the report an operating margin of 20% to  
27 ensure sufficient funds in the event of higher-than-expected participation in the Maine  
28 Clean Election Act. If any such report shows that the projected revenue for the  
29 subsequent 4-year period exceeds the projected expenses for that 4-year period plus the  
30 20% operating margin, the commission shall notify the Legislature and the Governor and  
31 request that the amount of expected funding that exceeds the expected demand on the  
32 fund plus the operating margin be transferred to the General Fund. The Department of  
33 Administrative and Financial Services, Bureau of Revenue Services shall assist the  
34 commission with revenue projections required by this subsection. If at any time the  
35 commission determines that projected revenue is not sufficient to cover the projected  
36 demand for funds in the 4-year period plus the operating margin, the commission may  
37 submit legislation to request additional funding.

23 distributions made pursuant to subsection 8-B must be made within 3 business days  
24 of certification by the commission of the required number of additional qualifying  
25 contributions.

26           B. For legislative candidates, any supplemental general election distributions made  
27 pursuant to subsections 8-C and 8-D must be made within 3 business days of  
28 certification by the commission of the required number of additional qualifying  
29 contributions.

33           **8-B. Distributions to participating gubernatorial candidates.** Distributions from  
34 the fund to participating gubernatorial candidates must be made as follows.

35           A. For an uncontested primary election, the total distribution of revenues is \$200,000  
36 per candidate.

37           B. For a contested primary election, the amount of revenues distributed is as follows:

38           (1) The initial distribution of revenues is \$400,000 per candidate;

1                   (2) For each increment of 800 additional qualifying contributions a candidate  
2                   collects and submits pursuant to subsection 8-E, not to exceed a total of 3,200  
3                   additional qualifying contributions, the supplemental distribution of revenues to  
4                   that candidate is \$150,000; and

25                   D. For a contested general election, the amount of revenues distributed is as follows:

26                   (1) The initial distribution of revenues is \$20,000 per candidate;

27                   (2) For each increment of 45 additional qualifying contributions a candidate  
28                   collects and submits pursuant to subsection 8-E, not to exceed a total of 360

6                 collects and submits pursuant to subsection 8-E, not to exceed a total of 120  
7                 additional qualifying contributions, the supplemental distribution of revenues to  
8                 that candidate is \$1,250; and

9                 (3) The total amount of revenues distributed for a contested general election may  
10                 not exceed \$15,000 per candidate.

11           **8-E. Collection and submission of additional qualifying contributions.**  
12           Participating candidates may collect and submit additional qualifying contributions in  
13           accordance with subsection 3-A to the commission as follows:

14                 A. For gubernatorial candidates, no earlier than October 15th of the year before the  
15                 year of the election and no later than 3 weeks before election day; and

16                 B. For legislative candidates, no earlier than January 1st of the election year and no  
17                 later than 3 weeks before election day.

18           Additional qualifying contributions may be submitted to the commission at any time in  
19           any amounts in accordance with the schedules in this subsection. The commission shall  
20           make supplemental distributions to candidates in the amounts and in accordance with the  
21           increments specified in subsections 8-B to 8-D. If a candidate submits additional  
22           qualifying contributions prior to a primary election in excess of the number of qualifying  
23           contributions for which a candidate may receive a distribution, the excess qualifying  
24           contributions must be counted as general election additional qualifying contributions if

28           **8-F. Amount of distributions.** The distribution amounts set forth in subsections  
29           8-B to 8-D apply for all elections prior to December 1, 2016. On December 1, 2016 and  
30           at least every 2 years thereafter the commission shall review and adjust the distribution  
31           amounts in those subsections based on the Consumer Price Index as reported by the  
32           United States Department of Labor, Bureau of Labor Statistics. If an adjustment is  
33           warranted by the Consumer Price Index, the distribution amounts must be adjusted,  
34           rounded to the nearest amount divisible by \$25. When making adjustments under this  
35           subsection, the commission may not change the number of qualifying contributions or  
36           additional qualifying contributions required to trigger an initial distribution or an

3 2. It amends the Maine Clean Election Act by adding a system of optional  
4 supplemental funding for participating Maine Clean Election Act candidates who collect  
5 additional qualifying contributions.

6 3. It establishes new baseline initial distribution amounts for Maine Clean Election  
7 Act candidates.

8 4. It authorizes the Commission on Governmental Ethics and Election Practices to  
9 impose enhanced penalties for campaign finance violations occurring shortly before  
10 election day.

11 5. It increases the baseline penalties for failure to file required reports.

12 6. It increases the maximum penalties for certain campaign finance violations.

13 7. It requires communications that are independent expenditures to include a  
14 conspicuous statement listing the top 3 funders of the entity making the independent  
15 expenditure.

16 8. It increases the amount of the annual transfer to the Maine Clean Election Fund  
17 from \$2,000,000 to \$3,000,000.

18 9. It requires the Commission on Governmental Ethics and Election Practices to  
19 report annually on the Maine Clean Election Fund's projected needs, including an  
20 operating margin of 20%.

21 10. It repeals the seed money requirement for gubernatorial candidates.

22 11. It adjusts the number of qualifying contributions required for initial certification

26 13. It provides rule-making authority for the Commission on Governmental Ethics  
27 and Election Practices regarding several of the statutory changes.

28 14. It directs the joint standing committee of the Legislature having jurisdiction over  
29 taxation matters to report out legislation to eliminate corporate tax expenditures totaling  
30 \$6,000,000 per biennium, prioritizing low-performing tax expenditures.
