COMMITTEE AMENDMENT "A" to H.P. 167, L.D. 235, Bill, "An Act To Adjust Appropriations and Allocations from the General Fund and Other Funds for the Expenditures of the Department of Education, the Maine Arts Commission and the Maine State Museum and To Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Year Ending June 30, 2015"

Amend the bill by striking out all of Part C.

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

**SUMMARY**

This amendment strikes Part C from the bill. Part C proposed to provide for the transfer of the payment for students who attend public charter schools authorized by the Maine Charter School Commission from the resident school administrative unit to the State.

### Fiscal Detail and Notes

This bill includes one-time appropriations and allocations in fiscal year 2014-15 to various programs within the Department of Education, the Maine Arts Commission and the Maine State Museum to support position reorganizations, reclassifications and payroll obligations.

This bill also amends the Lease-purchase authorization for the Maine learning technology initiative enacted in Public Law 2013, c. 368, Pt. JJ, section 1 to revise the principal and interest caps to include not only leases that the State pays for but leases that schools pay for. There is no fiscal impact to the State.
