10 11	<b>1-A.</b> Learner's permit; issuance. The following provisions apply to the issuance of a learner's permit.
12 13 14	A. Fees for a learner's permit may be collected only by the Secretary of State, the Secretary of State's designee or a person licensed as a driver education instructor under section 1354, subsection 2 in accordance with section 154, subsection 1.
15 16 17	B. Any required application materials for a learner's permit may be collected only by the Secretary of State, the Secretary of State's designee or a person licensed as a driver education instructor under section 1354, subsection 2.
18 19 20	C. Any required examination for a learner's permit may be administered only by the Secretary of State, the Secretary of State's designee or a person licensed as a driver education instructor under section 1354, subsection 2.
21 22 23	D. A learner's permit may be issued only by the Secretary of State, the Secretary of State's designee or a person licensed as a driver education instructor under section 1354, subsection 2.
24	SUMMARY
25 26	This bill allows a designee of the Secretary of State or a person licensed as a driver education instructor to do the following:
27	1. Collect fees for a learner's permit for a driver's license;
28	2. Collect application materials for a learner's permit;
29	3. Administer an examination for a learner's permit; and
30	4. Issue a learner's permit.
31	Current law allows only the Secretary of State to perform these functions.

Be it enacted by the People of the State of Maine as follows:
