| 9  | SUMMARY  |
| 10 | This bill makes the Adjutant General the next of kin to a deceased veteran who has           |
| 11 | no known living spouse or adult relatives and directs the Adjutant General to ensure the     |
| 12 | veteran receives all death benefits, including a grave marker from the United States         |
| 13 | Department of Veterans Affairs.  |
