16 17 18	E. The annual funding dedicated for the Local Road Assistance Program must be a percentage of the Highway Fund allocation to the Department of Transportation as follows:			
19	(1) Beginning July 1, 2015, 9.25%;			
20	(2) Beginning July 1, 2016, 9.5%;			
21	(3) Beginning July 1, 2017, 9.75%; and			
22	(4) Beginning July 1, 2018, 10%.			
23 24 25	On July 1, 2015 and every July 1st thereafter, the Commissioner of Transportation shall administratively adjust the base funding and the reimbursement rates per lane mile proportionately according to revenue available.

The bill increases funding to the Local Road Assistance program from 9% to 10% of the Highway Fund allocations to the Department of Transportation over a four-year period. The department will require Highway Fund allocations of \$560,653 in fiscal year 2015-16 and \$1,163,073 in fiscal year 2016-17. The bill does not increase revenue to the Highway Fund so Highway Fund deallocations would need to be made in the same amount in order for the Fund to balance.
