1 Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 12 MRSA §1893, sub-§3, ¶D, as enacted by PL 2007, c. 429, §1 and 3 affected by §3, is repealed. Sec. 2. 12 MRSA §13002, 2nd ¶, as enacted by PL 2003, c. 414, Pt. A, §2 and 4 affected by c. 614, §9, is amended to read: 5 6 All Except as provided in Title 36, section 1952-A, all taxes collected pursuant to this section must be transmitted forthwith to the Treasurer of State and credited to the General 7 Fund as undedicated revenue. The Legislature shall appropriate to the department in each 8 9 fiscal year an amount equal to the administrative costs incurred by the department in collecting revenue under this section. Those administrative costs must be verified by the 10 Department of Administrative and Financial Services. 11 12 Sec. 3. 12 MRSA §13104, sub-§4, as repealed and replaced by PL 2011, c. 129, 13 §1 and amended by c. 657, Pt. W, §§5 and 7 and PL 2013, c. 405, Pt. A, §24, is further 14 amended to read: 15 4. Fee. Except as provided in subsection 5, the annual snowmobile registration fee is 16 as follows: 17 A. For residents, \$40 \$50. The registration for a snowmobile owned by a resident is valid for one year, commencing on July 1st of each year; and 18 19 B. For nonresidents: 20 (1) Forty-three Forty-nine dollars for a 3-consecutive-day registration. A person may purchase more than one 3-day registration in any season; and 21 22 (2) Eighty eight Ninety-nine dollars for a seasonal registration-; and 23 (3) Seventy-five dollars for a 7-consecutive-day registration. A person may purchase more than one 7-day registration in any season. 24 25 The registration for a snowmobile owned by a nonresident must specify the dates for which the registration is valid. 26 27 Five dollars from each registration fee collected pursuant to this subsection must be 28 transferred to a special fund administered by the Off-Road Vehicle Division of the 29 Bureau of Parks and Lands within the Department of Agriculture, Conservation and Forestry. The funds must be used to assist any entity that has a snowmobile trail 30 grooming contract with the Bureau of Parks and Lands in the purchase of trail-grooming 31 32 equipment. The funds also may be used for the repair or overhaul of trail-grooming 33 equipment. 34 Seven Seventeen dollars from each resident snowmobile registration fee must be transferred to the Snowmobile Trail Fund of the Department of Agriculture, Conservation 35 and Forestry, Bureau of Parks and Lands. 36 37 Six dollars from each nonresident 3-day snowmobile registration fee and \$11 from each nonresident seasonal snowmobile registration fee must be transferred to the Snowmobile 38

Diesel fuel when bought for use in off-road machinery that is used primarily to groom snowmobile trails that are open to use by the public. 11 12 Sec. 5. 36 MRSA §3218, last ¶, as repealed and replaced by PL 2003, c. 390, 13 §17, is amended to read: 14 All fuel Fuel qualifying for a refund under this section is subject to the use tax imposed by chapter 215, unless exempted under section 1760. 15 **SUMMARY** 16 17 This bill makes the following changes related to snowmobile registration and sales tax on diesel fuel used in snowmobile trail-grooming machinery. 18 1. It increases the resident snowmobile registration fee from \$40 to \$50 and allocates 19 20 the additional \$10 to the Snowmobile Trail Fund of the Department of Agriculture, Conservation and Forestry, Bureau of Parks and Lands. 21 22 2. The bill increases the 3-day nonresident snowmobile registration fee from \$43 to \$49 and increases the seasonal nonresident registration from \$88 to \$99 and allocates the 23 additional revenue to the Snowmobile Trail Fund of the Department of Agriculture, 24 Conservation and Forestry, Bureau of Parks and Lands. 25 26 3. It creates a 7-day nonresident snowmobile registration with a fee of \$75. 27 4. It amends the law governing the special fuel tax to make it clear that fuel 28 qualifying for a refund under that law does not lose the sales tax exemption created in the 29 bill for diesel fuel used in snowmobile trail-grooming machinery.
