11	Amend the bill by striking out the title and substituting the following:
12 13	'An Act To Add Acetylfentanyl and Methylfentanyl Derivatives to the List of Schedule W Drugs'
14 15	Amend the bill by inserting after the title and before the enacting clause the following:
16 17	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
18 19 20 21 22	Whereas, law enforcement agencies have informed the Legislature that drugs that are harmful to the people of Maine, including acetylfentanyl and methylfentanyl derivatives, have recently been found in the State in increasing quantities and it is in the public interest that the criminal laws prohibiting acetylfentanyl and methylfentanyl derivatives be strengthened without delay; and
23 24 25 26	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'
27 28 29	Amend the bill in section 1 in paragraph I in the last line (page 1, line 9 in L.D.) by inserting after the following: "acetylfentanyl" the following: 'and any methylfentanyl derivatives'
30	Amend the bill by adding before the summary the following:
31 32	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

2 3	This amendment adds an emergency preamble and emergency clause to the bill. The amendment adds to the list of Schedule W drugs any methylfentanyl derivatives.

Establishes new Class A, Class B and Class C crimes; increases correctional and judicial costs. The collection of additional fines may also increase General Fund revenue by minor amounts. As acetylfentanyl has only rarely been seen in Maine no cases are anticipated in the current biennium.
