15	'A. Family care throughout the family members' lifespans;'
16 17	Amend the bill in section 5 in subsection 11 by striking out all of paragraph E (page 2, line 12 in L.D.) and inserting the following:
18	'E. Women's health and gender-related care; and'
19 20	Amend the bill in section 12 in §2205-C in subsection 7 by striking out all of paragraph D (page 5, line 6 in L.D.) and inserting the following:
21 22 23	'D. Prescribe, order, administer, dispense and furnish therapeutic measures. For purposes of this paragraph, a certified registered nurse anesthetist may prescribe schedule II, III, IIIN, IV and V prescription drugs under this subsection only:

25 26	(2) To an individual for whom the certified registered nurse anesthetist has, at the time of the prescription, established a client or patient record.
