4 SUMMARY

This bill provides that a retired marine patrol officer who applies for a Class I, Class II or Class III lobster and crab fishing license, an elver fishing license, a hand fishing scallop license, a scallop dragging license, a handfishing sea urchin license, a sea urchin dragging license or a sea urchin hand-raking and trapping license must be issued up to 2 of the licenses, but in no case 2 of the same license, if certain conditions are met. To be issued a license, the applicant must be eligible for service retirement benefits under the State Employee and Teacher Retirement Program and the issuance of the license must not result in an increase in the total number of licenses outstanding in the fishery for which the license is issued.
