17	3. Eligible person. "Eligible person" means a person who is qualified to receive
18	general assistance from a municipality according to standards of eligibility determined by
19	the municipal officers whether or not that person has applied for general assistance.
20	"Eligible person" does not include a person who is a fugitive from justice as defined in
21 22	Title 15, section 201, subsection 4. In accordance with 8 United States Code, Section
22	<u>1621(d)</u> , an "eligible person" who is a noncitizen is limited to a person who is lawfully present in the United States or who is pursuing a lawful process to apply for immigration
23	relief.'
