19 20	Sec. 2. 7 MRSA §3907, sub-§23-A, as enacted by PL 2007, c. 439, §5, is amended to read:

"Rescue group" means an organization or individual that receives <u>domesticated</u> animals that have been abandoned, surrendered or removed from an animal facility or that takes in homeless dogs or cats and sells, gives or otherwise places the animals in private homes. "Rescue group" does not include a facility licensed under chapter 723.'

27	This committee amendment, which is the	manimous report of the committee, amends	
28	the definition of "animal shelter" to include rescue groups. The word "domesticated" is		
29 30	included in the definitions of "animal shelter" and "rescue group" to ensure that wild animal rescues under the jurisdiction of the Department of Inland Fisheries and Wildlife
