Fiscal Detail and Notes

The bill creates a gun violence restraining order and includes a General Fund appropriation of \$39,000 in fiscal year 2015-16 and \$6,500 in 2016-17 and a Highway Fund allocation of \$21,000 in fiscal year 2015-16 and \$3,500 in 2016-17 to the Department of Public Safety to create and maintain a computer database for gun violence restraining orders. It also includes a General Fund appropriation of \$455,023 in fiscal year 2015-16 and \$296,997 in fiscal year 2016-17 for the Judicial Department for additional staff and technology costs as a result of creating the gun violence restraining order.
