#### COMMITTEE AMENDMENT " to H.P. 783, L.D. 1145 **SUMMARY** 1 2 This amendment clarifies the terminology used to describe the emergency treatment 3 to be involuntarily provided to reflect that the treatment must be a currently recognized standard of treatment. 4 5 This amendment clarifies that the sources of available history and other information may include family members without implying family members are always a reliable 6 source. 7 8 This amendment requires that when a physician or clinical psychologist has evaluated 9 a person for the purpose of providing a 2nd opinion on whether the person meets the 10 criteria for emergency admission to a psychiatric hospital and determines that the person does not meet the criteria, the physician or clinical psychologist must record the discharge 11 upon the written application for emergency admission. The application must contain a 12 statement that the person does not satisfy the criteria for emergency admission, 13 14 This amendment clarifies the standard for a person's consent to informal voluntary 15 admission once the involuntary commitment process has started. 16 FISCAL NOTE REQUIRED
