- 1 Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 15 MRSA §1023, sub-§4, ¶C, as repealed and replaced by PL 2013, c. 3 424, Pt. A, §6, is amended to read: 4 C. In a case involving domestic violence, set preconviction bail for a defendant 5 before making a good faith effort to obtain from the arresting officer, the responsible prosecutorial office, a jail employee or other law enforcement officer: 6 (1) A brief history of the alleged abuser; 7 8 (2) The relationship of the parties; 9 (3) The name, address, phone number and date of birth of the victim; 10 (4) Existing conditions of protection from abuse orders, conditions of bail and conditions of probation; 11 (5) Information about the severity of the alleged offense, including, when 12 13 feasible, information from the victim when the alleged offense is a violation of Title 17-A, section 207, 207-A, 208, 208-B, 208-C, 209, 209-A, 210, 210-A, 14 210-B, 210-C, 211, 211-A or 213; and 15 (6) Beginning no later than January 1, 2015, the results of a validated, evidence-16 17 based domestic violence risk assessment recommended by the Maine Commission on Domestic and Sexual Abuse, established in Title 5, section 18 19 12004-I, subsection 74-C, and approved by the Department of Public Safety conducted on the alleged abuser when the results are available; 20 21 Sec. 2. 15 MRSA §1026, sub-§3, ¶A, as amended by PL 2013, c. 227, §1, is 22 further amended to read: 23 If, after consideration of the factors listed in subsection 4, the judicial officer A. 24 determines that the release described in subsection 2-A will not reasonably ensure the appearance of the defendant at the time and place required, will not reasonably ensure 25 26 that the defendant will refrain from any new criminal conduct, will not reasonably ensure the integrity of the judicial process or will not reasonably ensure the safety of 27 others in the community, the judicial officer shall order the pretrial release of the 28 29 defendant subject to the least restrictive further condition or combination of 30 conditions that the judicial officer determines will reasonably ensure the appearance 31 of the defendant at the time and place required, will reasonably ensure that the defendant will refrain from any new criminal conduct, will reasonably ensure the 32 33 integrity of the judicial process and will reasonably ensure the safety of others in the
- (1) Remain in the custody of a designated person or organization agreeing to
 supervise the defendant, including a public official, public agency or publicly
 funded organization, if the designated person or organization is able to
 reasonably ensure the appearance of the defendant at the time and place required,
 that the defendant will refrain from any new criminal conduct, the integrity of the
 judicial process and the safety of others in the community. When it is feasible to
 do so, the judicial officer shall impose the responsibility upon the defendant to

1 2 3 4 5	produce the designated person or organization. The judicial officer may interview the designated person or organization to ensure satisfaction of both the willingness and ability required. The designated person or organization shall agree to notify immediately the judicial officer of any violation of release by the defendant;
6	(2) Maintain employment or, if unemployed, actively seek employment;
7	(3) Maintain or commence an educational program;
8 9	(4) Abide by specified restrictions on personal associations, place of abode or travel;

Every order for the pretrial release of a defendant who is released on bail for an alleged violation of Title 17-A, section 207, 207-A, 208, 208-B, 208-C, 209, 209-A, 210, 210-A, 210-B, 210-C, 211, 211-A or 213 must include a requirement that the defendant participate in an electronic monitoring program, if an electronic monitoring program is available, and pay the full cost of participation in that program.

In setting bail, the judicial officer shall, on the basis of an interview with the defendant, information provided by the defendant's attorney and, information provided by the attorney for the State or an informed law enforcement officer if the attorney for the State is not available, when feasible any information from the victim when the alleged offense is a violation of Title 17-A, section 207, 207-A, 208, 208-B, 208-C, 209, 209-A, 210, 210-A, 210-B, 210-C, 211, 211-A or 213, and other reliable information that can be obtained, shall take into account the available information concerning the following:

20 §1032. Additional bail requirements applicable to certain crimes

21 Notwithstanding any provision of law to the contrary, if bail has been set for a violation of Title 17-A, section 207, 207-A, 208, 208-B, 208-C, 209, 209-A, 210, 210-A, 22 23 210-B, 210-C, 211, 211-A or 213, the requirements of this section apply in addition to 24 any applicable conditions imposed under this subchapter. For a violation of section 207, 25 207-A, 208, 208-B or 208-C, the minimum amount at which bail may be set is \$4,000. For a violation of section 209, 209-A, 210, 210-A, 210-B, 210-C, 211, 211-A or 213, the 26 27 minimum amount at which bail may be set is \$2,000. Bail set pursuant to this section must be paid in full in cash without the use of a bond or surety. 28

SUMMARY

30 This bill requires a minimum cash bail for defendants charged with certain crimes under the Maine Revised Statutes, Title 17-A. The bill requires a minimum cash bail of 31 \$4,000 for a charge of assault under section 207, domestic violence assault under section 32 207-A, aggravated assault under section 208, elevated aggravated assault under section 33 34 208-B or elevated aggravated assault on a pregnant person under section 208-C. The bill requires a minimum cash bail of \$2,000 for a charge of criminal threatening under section 35 36 209, domestic violence criminal threatening under section 209-A, terrorizing under section 210, stalking under section 210-A, domestic violence terrorizing under section 37 210-B, domestic violence stalking under section 210-C, reckless conduct under section 38 211, domestic violence reckless conduct under section 211-A or aggravated reckless 39 40 conduct under section 213.

The bill provides that a defendant who is released on bail on a charge of a violation of Title 17-A, section 207, 207-A, 208, 208-B, 208-C, 209, 209-A, 210, 210-A, 210-B, 210-C, 211, 211-A or 213 must be required to participate in an electronic monitoring program, if an electronic monitoring program is available, and must be required to pay the full cost of participation in that program.

6 The bill requires bail commissioners and judicial officers when setting preconviction 7 bail for a defendant for an alleged violation of Title 17-A, section 207, 207-A, 208, 8 208-B, 208-C, 209, 209-A, 210, 210-A, 210-B, 210-C, 211, 211-A or 213, when feasible, 9 to obtain information from the victim.
