Record of tests for water samples 15 A person requesting a water sample test must indicate the source of the water sample. 16 A laboratory that tests any public water system for drinking water program compliance 17 mandates shall forward a copy of the test results to the department. A laboratory that 18 tests any residential private drinking water well for contaminants identified by the 19 department pursuant to section 2660-T shall forward a copy of all test results to the 20 department by an annual date set by the department. The department shall keep 21 confidential the addresses included on the copy of residential private drinking water well 22 test results and use them only for the purposes of recording multiple tests for the same 23 well. The department shall establish by rule a system for facilitating the collection of 24 data from private laboratories to avoid significant new costs for private laboratories and 25 the department. Rules adopted pursuant to this section are routine technical rules as 26 defined in Title 5, chapter 375, subchapter 2-A.' 27 Amend the bill in section 4 in subchapter 8 by striking out all of section 2660-U 28 (page 2, lines 11 to 32 in L.D.) and inserting the following: 29 '§2660-U. Fees 30 The Health and Environmental Testing Laboratory established in section 565 shall 31 collect a fee not to exceed \$10 from a person or entity ordering a water test for a water 32 sample from a residential private drinking water well. The fees collected must be 33 credited to the Private Well Safe Drinking Water Fund established in section 2660-X and 34 used for the purpose of increasing testing of residential private drinking water wells. Fiscal Detail and Notes

The bill includes allocations to the Department of Health and Human Services (DHHS) of \$56,768 in fiscal year 2015-16 and \$75,690 in fiscal year 2016-17 to establish the Private Well Safe Drinking Water Fund for technology updates, educational material updates and educational outreach. The Maine Environmental Health Laboratory within DHHS will collect \$56,768 in fiscal year 2015-16 and \$75,690 in fiscal year 2016-17 from a fee, not to exceed \$10 dollars, on residential private drinking water well tests.
