| 24 | fentanyl for which the bill establishes the penalties is fentanyl powder. The amendment |
| 25 | deletes from the bill the word clandestine in regard to the methamphetamine laboratories |
| 26 | that are criminalized in the bill. The amendment reduces possession of oxycodone in the |
| 27 | form of pills, capsules, tablets, mixtures or substance in the aggregate less than 30 |
| 28 29 | milligrams and possession of hydrocodone or hydomorphone from a Class C crime to a Class D crime. |

Current biennium cost increase - General Fund

Correctional and Judicial Impact Statements

Establishes new Class A, Class B and Class C crimes, increases correctional and judicial costs.

Decreases a Class C crime to a Class D crime, potentially shifting incarceration costs from the State to the county and regional jails.

The additional General Fund cost to the Maine Commission on Indigent Legal Services is estimated to be \$18,000 annually.

The net impact on General Fund fine revenue cannot be estimated at this time.
