	21	duty upon the Secretary of State to inspect, evaluate or investigate a record that is

2	23	2. Removal. The Secretary of State may remove a record that has been filed or
	24	recorded with the Secretary of State if the Secretary of State determines that the record
	25	was filed or recorded erroneously because the record was not required or authorized to be
	26	filed or recorded with the Secretary of State or the Secretary of State has reasonable cause
	27	to believe that the record is materially false or fraudulent. If the Secretary of State
