1 **Sec. 1. Study of court facility needs. Resolved:** That the Judicial Department
2 shall conduct or contract for architectural feasibility studies to improve court facilities in
3 Oxford County, Waldo County and York County. The Judicial Department shall report
4 on the findings of the feasibility studies to the joint standing committee of the Legislature
5 having jurisdiction over appropriations and financial affairs and the joint standing
6 committee of the Legislature having jurisdiction over judiciary matters by January 1,
7 2017; and be it further

18 **SUMMARY**

19 This resolve directs the Judicial Department to conduct or contract for architectural
20 feasibility studies to improve court facilities in Oxford County, Waldo County and York
21 County and report to the joint standing committee of the Legislature having jurisdiction
22 over appropriations and financial affairs and the joint standing committee of the
23 Legislature having jurisdiction over judiciary matters by January 1, 2017. It also
24 appropriates \$300,000 in one-time funding for the studies in fiscal year 2015-16.
