9 L.D. 1272, Bill, "An Act To Strengthen the Protections for Senior Citizens in the State"

Amend the amendment in the first line after the title (page 1, line 11 in amendment)
11 by striking out the following: "section 7 and inserting the following:" and inserting the
12 following: 'section 7.'

Amend the amendment by striking out all of section 7 (page 1, lines 12 to 23 in
14 amendment) and inserting the following:

15

'Amend the bill in section 8 in the 2nd line (page 2, line 32 in L.D.) by inserting
16 before the following: "positions" the following: 'on a limited-period basis'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or
18 section number to read consecutively.'

SUMMARY

This amendment removes the appropriations and allocations section from the bill as
21 replaced by Committee Amendment "A." This amendment also amends the funding
22 section of the bill to specify that the positions in the Attorney General's Office are
23 limited-period positions.

Fiscal Detail and Notes

This amendment eliminates the General Fund appropriation of \$205,969 in fiscal year 2015-16 and \$202,599 in fiscal year 2016-17 for the Department of the Attorney General to investigate and prosecute the financial exploitation of dependent adults. It also clarifies that any positions funded with other available funds be limited-period.
