11	Amend the bill by striking out the title and substituting the following:
12 13	'Resolve, To Study the Effect of Compensated Union Leave in State Collective Bargaining Contracts'
14 15	Amend the bill by striking out everything after the title and before the summary and inserting the following:
16 17	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
18 19 20	Whereas, the State is party to collective bargaining contracts that allow employees the right to compensated leave for activities involving the employees' collective bargaining agent, also known as union leave or organizational leave; and
21 22	Whereas, these collective bargaining agent activities have no bearing on the tasks for which such state employees have been hired by the State; and
23 24	Whereas, it is currently unclear the extent of the impact of compensated union leave on state resources and the benefit of such leave to the State; and
25 26	Whereas, state resources are extremely limited and it is in the best interest of the citizens of the State that state resources are spent as efficiently as possible; and
27 28 29	Whereas, the study authorized by this resolve must be initiated before the 90-day period expires in order that the study may be completed and a report produced in time for submission to the next legislative session; and
30 31 32 33	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. The Study Commission on State Union Leave established. **Resolved:** That the Study Commission on State Union Leave, referred to in this resolve as "the study commission" is established; and be it further

Sec. 2. Study commission membership. **Resolved:** That the study commission consists of 13 members appointed as follows:

1. Six members appointed by the President of the Senate as follows:

A. Four members of the Senate, 2 from each of the 2 parties holding the largest number of seats in the Legislature;

B. A representative of the Maine Labor Relations Board; and

C. A representative of the judicial branch;

2. Five members appointed by the Speaker of the House as follows:

A. Four members of the House of Representatives, 2 from each of the 2 parties holding the largest number of seats in the Legislature; and

B. A representative of the Maine State Employees Association;

15 3. The Executive Director of the Legislative Council or the executive director's 16 designee; and

4. The Commissioner of Administrative and Financial Services or the commissioner's designee; and be it further

19 Sec. 3. Chairs. Resolved: That the first-named Senate member is the Senate 20 chair and the first-named House of Representatives member is the House chair of the 21 study commission; and be it further

22 Sec. 4. Appointments; convening of the study commission. Resolved: 23 That all appointments must be made no later than 30 days following the effective date of 24 this resolve. The appointing authorities shall notify the Executive Director of the 25 Legislative Council once all appointments have been completed. After appointment of all 26 members, the chairs shall call and convene the first meeting of the study commission. If 27 30 days or more after the effective date of this resolve a majority of but not all 28 appointments have been made, the chairs may request authority and the Legislative 29 Council may grant authority for the study commission to meet and conduct its business; 30 and be it further

31 Sec. 5. Duties. Resolved: That the study commission shall conduct a study on the impact of state-compensated leave for an employee to participate in activities related 32 33 to the employee's collective bargaining agent, both in terms of overall financial cost to the 34 State and in terms of lost employee time, and on the benefits of such leave to the State; 35 and be it further

36 Sec. 6. Staff assistance. Resolved: That the Legislative Council shall provide necessary staffing services to the study commission; and be it further

38 Sec. 7. Report. Resolved: That, no later than December 2, 2015, the study 39 commission shall submit a report that includes its findings and recommendations, 40 including suggested legislation, for presentation to the Joint Standing Committee on

Labor, Commerce, Research and Economic Development, which may report out a bill related to the report to the Second Regular Session of the 127th Legislature.

Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

SUMMARY

This amendment replaces the bill with a resolve that establishes the Study Commission on State Union Leave to study the impact of the practice of statecompensated leave for an employee to participate in activities related to the employee's collective bargaining agent, both in terms of overall financial cost to the State and in terms of lost employee time, and to also study the benefits of such leave to the State. The study commission must report back on its findings and recommendations by December 2, 2015, and the Joint Standing Committee on Labor, Commerce, Research and Economic Development may report out a bill related to the report.

Legislative Cost/Study

The general operating expenses of this study are projected to be \$4,250 in fiscal year 2015-16. The Legislature's proposed budget includes \$10,000 in fiscal year 2015-16 for legislative studies. Whether this amount is sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature. The additional costs of providing staffing assistance to the study during the interim can be absorbed utilizing existing budgeted staff resources. If more than 4 meetings are held during the interim the estimated cost for each additional meeting is projected to be \$1,000 for legislative per diem and expenses.

Fiscal Detail and Notes

Additional costs to the Maine Labor Relations Board and the Department of Administrative and Financial Services to serve as members of the Study on State Union Leave can be absorbed within existing budgeted resources.
