The commission shall adopt rules to implement this subsection. Rules adopted under this subsection are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.'

SUMMARY

7 This amendment, which is the minority report, strikes the bill and instead allows the 8 Public Utilities Commission, when it determines that electricity supply prices are at 9 historically high levels, to set the alternative compliance payment rate for new renewable 10 capacity resources at a level that reduces higher revenue for generators of new renewable capacity resources. The amendment also specifies that if the annualized average standard 11 12 offer electricity supply pricing for residential customers is 10¢ per kilowatt hour or higher, the commission must reduce the alternative compliance payment rate by 100%, 13 which has the effect of suspending the renewable portfolio requirement. 14

Any revenue loss to the Efficiency Maine Trust from reducing the alternative compliance payments under certain circumstances on competitive electricity providers satisfying portfolio requirements for new renewable capacity resources is not expected to be significant. From fiscal year 2013-14 through fiscal year 2015-16 to date only \$5,475 has been collected from these payments.
