R. of S.	COMMITTEE AMENDMENT " " to S.P. 493, L.D. 1360
1	Amend the bill by relettering or renumbering any nonconsecutive Part letter or
2	section number to read consecutively.
3	SUMMARY
4	This amendment strikes a reference to a loan repayment program from the title of the
5	chapter of law proposed to be enacted in the bill. The amendment also adds high school
6	seniors to the definition of "STEM student." The amendment changes the maximum loan
7	term from 4 years to 5 years and strikes a reference to 8% loans being available to
8	students who, upon graduation, are not employed in the field of science, technology,
9	engineering and mathematics.
10	Finally, the amendment adds a contingency funding provision that prohibits the
11	Finance Authority of Maine from providing loans through the Maine Science,
12	Technology, Engineering and Mathematics Loan Program in fiscal year 2015-16 unless
13	legislation is enacted during the First Regular Session of the 127th Legislature that
14	provides additional funding for the General Purpose Aid for Local Schools program for
15	fiscal year 2015-16 and for the Maine Community College System for fiscal year 2015-
16	16 and fiscal year 2016-17.

Fiscal Detail and Notes

This bill establishes the Maine Science, Technology, Engineering and Mathematics Loan Program within the Finance Authority of Maine (FAME) and provides a one-time General Fund appropriation of \$10,000,000 in fiscal year 2015-16 to capitalize a newly created Maine Science, Technology, Engineering and Mathematics Loan Fund within FAME to provide loans to students pursuing undergraduate and graduate degrees in the fields of science, computer science, technology, engineering and mathematics.

This legislation makes the implementation of the loan program contingent upon an additional \$40,199,613 being appropriated in fiscal year 2015-16 to the General Purpose Aid for Local Schools program within the Department of Education and an additional \$2,000,000 in fiscal year 2015-16 and \$4,000,000 in fiscal year 2016-17 being appropriated to the Maine Community College System as part of LD 1019, the 2016-2107 biennial budget. Before final enactment in the Senate, this bill will be placed on the Special Appropriations Table to await final legislative actions on the budget, when it will be known whether or not the contingency requirements in this bill have been met and if this legislation can move forward.

This legislation also provides that interest earnings from the fund may be used to cover the expenses incurred by FAME to administer the program and the fund. FAME has indicated that this provision will allow for sufficient resources to cover the administrative costs and no additional General Fund appropriations will be required.
