3 4	4. Division. As used in section 7707, "division" means the Department of Health and Human Services, Division of Licensing and Regulatory Services.
5	5. Reportable incident. As used in section 7707, "reportable incident" means:
6 7	A. A child's death that occurs while the child is in the care of an entity required to report under section 7707, subsection 1; and
8 9 10	B. An injury or trauma to a child that occurs while the child is in the care of an entity required to report under section 7707, subsection 1 and results in the transportation of the child to a hospital by emergency medical services personnel.

A child care facility licensed pursuant to section 8301-A, subsection 2; a family child care provider certified pursuant to section 8301-A, subsection 3; and a nursery school licensed pursuant to section 8402 shall report reportable incidents in accordance with this section. Notification by next business day. An entity required to report pursuant to subsection 1 shall submit a division-approved reportable incident form to the division by the next business day after a reportable incident occurred. The form must include at least

22	B. The time the reportable incident occurred;
23	C. The name of the entity;

to the physical or mental health, safety or well-being of a child beir	ng served by these
entities. Incidents must be reported to the Department of Health and	l Human Services
Division of Licensing and Regulatory Services. The bill requires writ	tten notification by
the next business day after the incident occurred.
