1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §10001, sub-§6, ¶¶E and M**, as enacted by PL 2003, c. 414,
3 Pt. A, §2 and affected by c. 614, §9, are repealed.

4 **Sec. 2. 12 MRSA §10001, sub-§6, ¶T**, as enacted by PL 2003, c. 414, Pt. A, §2
5 and affected by c. 614, §9, is amended to read:

6 T. White sucker, (*Catostomus commersoni*); and

7 **Sec. 3. 12 MRSA §10001, sub-§6, ¶U**, as amended by PL 2007, c. 159, §1, is
8 repealed.

9 **Sec. 4. 12 MRSA §10001, sub-§§16 and 18**, as enacted by PL 2003, c. 414, Pt.
10 A, §2 and affected by c. 614, §9, are amended to read:

11 **16. Eel.** "Eel" means a member of the species *Anguilla rostrata* in that stage of its
12 life cycle when it is 6 2 inches or more in length.

13 **18. Elver.** "Elver" means a member of the species *Anguilla rostrata* in that stage of
14 its life cycle when it is less than 6 2 inches in length.

15 **Sec. 5. 12 MRSA §10001, sub-§36-A** is enacted to read:

16 **36-A. Lamprey eel.** "Lamprey eel" means the species *Petromyzon marinus* (sea
17 lamprey).

18 **Sec. 6. 12 MRSA §10001, sub-§59-A** is enacted to read:

19 **59-A. Sucker.** "Sucker" means only the species *Catostomus commersoni* (white
20 sucker) and the species *Catostomus catostomus* (longnose sucker).

21 **Sec. 7. 12 MRSA §10902, sub-§1**, as enacted by PL 2003, c. 414, Pt. A, §2 and
22 affected by c. 614, §9, is amended to read:

23 **1. Conviction or adjudication of violation or noncompliance with a permit**
24 **restriction.** ~~Any Noncompliance with a permit restriction or any~~ conviction or
25 adjudication for a violation of this Part is grounds for suspension of any license or permit
26 issued under this Part. Except where provided by law, the commissioner shall determine
27 the suspension period. To suspend a license or permit based upon a conviction or
28 adjudication, the commissioner shall follow the procedures under section 10903. A
29 suspension or revocation of a license by the District Court is subject to the provisions of
30 subsection 5.
