### **An Act To Establish the Public Higher Education Systems Coordinating Committee**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 20-A MRSA §9**, as amended by PL 2013, c. 368, Pt. DDDDD, §1, is  
3 repealed and the following enacted in its place:

4 **§9. Public Higher Education Systems Coordinating Committee**

5 **1. Committee established.** The Public Higher Education Systems Coordinating  
6 Committee, referred to in this section as "the committee," is established to promote  
7 efficiency, cooperative effort and strategic planning between the University of Maine  
8 System and the Maine Community College System, referred to in this section as "the  
9 systems."

10 **2. Membership.** The committee consists of the Chancellor of the University of  
11 Maine System, the Chair of the Board of Trustees of the University of Maine System, the  
12 President of the Maine Community College System and the Chair of the Board of  
13 Trustees of the Maine Community College System. The members of the committee may  
14 appoint designees to a subcommittee.

15 **3. Duties.** The committee shall seek to achieve greater collaboration and  
16 cooperation between the systems in order to address issues including, but not limited to,  
17 the following:

18 A. Improving college affordability;

19 B. Minimizing or eliminating barriers to student transfer between the systems;

20 C. Reducing unnecessary duplication of programs between the systems;

21 D. Identifying opportunities for sharing best practices and individual efficiencies,  
22 building cross-system economies of scale and sharing of resources;

23 E. Recommending changes to state laws that would improve the systems' efficiency  
24 or effectiveness;

25 F. In consultation with the President of the Maine Maritime Academy and the Chair  
26 of the Board of Trustees of the Maine Maritime Academy, investigating and pursuing  
27 opportunities for collaboration and resource sharing with the Maine Maritime  
28 Academy. The committee shall notify the President of the Maine Maritime Academy  
29 of committee meetings and agenda items; and

30 G. In consultation with the commissioner and the chair of the state board,  
31 investigating and pursuing opportunities to improve college preparation, transition  
32 and completion for Maine's secondary students, including supporting early college  
33 opportunities and improving credit transfer between secondary and postsecondary  
34 school systems.

35 **4. Meetings.** The committee shall meet at least twice each year and the committee  
36 members' designees may meet more frequently. The chancellor shall convene the first  
37 meeting of the committee by October 15, 2015. The committee shall establish a meeting  
38 schedule, and the initial work must include an accounting of the members' prior and  
39 current efforts to promote efficiency, cooperative effort and strategic planning between

1 the systems. The committee shall elect a chair from among its members to serve for a  
2 term to be determined by the committee.

3 **5. Reporting.** The committee shall report succinctly on its deliberations and any  
4 recommendations to the Governor and the joint standing committee of the Legislature  
5 having jurisdiction over education matters by February 15th each year.

## 6 SUMMARY

7 This bill is reported out pursuant to joint order by the Joint Standing Committee on  
8 Education and Cultural Affairs.

9 The bill replaces the Education Coordinating Committee with the Public Higher  
10 Education Systems Coordinating Committee to:

11 1. Promote efficiency, cooperative effort and strategic planning between the  
12 governance structures of the University of Maine System and the Maine Community  
13 College System and address issues including, but not limited to, improving college  
14 affordability, promoting student transfer between the systems, reducing the duplication of  
15 programs, identifying opportunities for building cross-system economies of scale and  
16 sharing of resources and recommending statutory changes to improve the efficiency or  
17 effectiveness of the public institutions of higher education;

18 2. Investigate and pursue opportunities for collaboration and resource sharing with  
19 the Maine Maritime Academy; and

20 3. With the Commissioner of Education and the Chair of the State Board of  
21 Education, investigate and pursue opportunities to improve college preparation, transition  
22 and completion for Maine's secondary students.

23 The first meeting of the committee must be convened by October 15, 2015 and the  
24 committee is directed to meet at least twice each year.

25 The committee is required to submit a report on its deliberations, including any  
26 recommendations, to the Governor and the joint standing committee of the Legislature  
27 having jurisdiction over education matters by February 15th each year.
