19 20 21	5. Supervision of dental therapists. A dentist, referred to in this section as the "supervising dentist," who employs or supervises a dental hygiene therapist shall comply with this subsection.

A supervising dentist shall arrange for another dentist or specialist to provide any services needed by a patient of a dental hygiene therapist supervised by that dentist that are beyond the scope of practice of the dental hygiene therapist and that the supervising dentist is unable to provide.
26 27 28	B. The supervising dentist is responsible for all authorized services and procedures performed by the dental hygiene therapist pursuant to a written practice agreement executed by the dentist pursuant to section 18377.
29 30	C. Revisions to a written practice agreement must be documented in a new written practice agreement signed by the supervising dentist and the dental hygiene therapist.
31 32 33	D. A supervising dentist who signs a written practice agreement shall file a copy of the agreement with the board, keep a copy for the dentist's own records and make a copy available to patients of the dental hygiene therapist upon request.

1. Scope of practice. A dental hygiene therapist may perform the following

procedures in limited practice settings, if authorized by a written practice agreement with

a dentist licensed in this State pursuant to subsection 3.

1 2 3	A. To the extent permitted in a written practice agreement, a dental hygiene therapist may provide the care and services listed in this paragraph only under the direct general supervision of the supervising dentist:
4 5	(1) Perform oral health assessments, pulpal disease assessments for primary and young teeth, simple cavity preparations and restorations and simple extractions;
6 7	(2) Prepare and place stainless steel crowns and aesthetic anterior crowns for primary incisors and prepare, place and remove space maintainers;
8	(3) Provide referrals;
9	(4) Administer local anesthesia and nitrous oxide analgesia;
10	(5) Perform preventive services;
11 12 13	(6) Conduct urgent management of dental trauma, perform suturing, extract primary teeth and perform nonsurgical extractions of periodontally diseased permanent teeth if authorized in advance by the supervising dentist;
14 15	(7) Provide, dispense and administer anti-inflammatories, nonprescription analgesics, antimicrobials, antibiotics and anticaries materials;
16	(8) Administer radiographs; and
17 18	(9) Perform other related services and functions authorized by the supervising dentist and for which the dental hygiene therapist is trained.; and
19	(10) Perform the procedures listed in section 18374, subsections 1 and 2.

A written practice agreement is a signed document that outlines the functions that the dental hygiene therapist is authorized to perform, which may not exceed the scopes of practice specified in subsections 1 and 2. A dental hygiene therapist may practice only under the standing order of the supervising dentist, may provide only care that follows written protocols and may provide only services that the dental hygiene therapist is authorized to provide by the written practice agreement.

4	SUMMARY
5 6 7	This amendment corrects conflicts created by the enactment of Public Law 2015 chapter 429, which repealed and replaced the laws governing dental professionals. This amendment makes the following changes to the provisions of law enacted in chapter 429:
8	1. It changes the term "dental hygiene therapist" to "dental therapist";
9	2. It changes the term "dental hygiene therapy" to "dental therapy";
10 11 12 13	3. It specifies that an applicant who has successfully completed a master's degree instead of a bachelor's degree or higher, in a dental therapy education program that is accredited by either the Board of Dental Practice or the American Dental Association Commission on Dental Accreditation or a successor organization approved by the board meets the requirements for having completed a dental therapy education program;
15 16	4. It increases the number of hours of supervised clinical practice that an applicant for dental therapist authority must complete from 2,000 to 2,500;
17 18 19	5. It removes the requirements that a dental therapy education program be consistent with a specified model curriculum, be consistent with programs in other states and be approved by the board;
20 21	6. It limits to 5 the number of dental therapists that a single dentist may supervise at one time; and
22 23	7. It removes the requirement that a dental therapist practice under the direct supervision of a dentist.
