#### Fiscal Detail and Notes

The bill includes a General Fund appropriation to the Department of Health and Human Services of \$3,211,505 in fiscal year 2016-17 to provide an annual cost-of-living adjustment required by Chapter 101: MaineCare Benefits Manual, Chapter III, Section 67, Principles of Reimbursement for Nursing Facilities. This bill also includes a Federal Expenditures Fund allocation for the FMAP match and an Other Special Revenue Funds allocation for the Nursing Facility tax.
