Fiscal Detail and Notes

This amendment reduces the proposed fiscal year 2015-16 transfer from the unappropriated surplus of the General Fund to the Maine Budget Stabilization Fund by \$500,000 and instead transfers that \$500,000 to the Maine Clean Election Fund in fiscal year 2015-16. The amendment also includes an Other Special Revenue Funds allocation of \$500,000 in fiscal year 2015-16 to the Commission on Governmental Ethics and Election Practices to allow expenditure of the transferred money.
