SUMMARY

This amendment strikes the emergency preamble and emergency clause and adjusts certain dates and funding accordingly. Specifically, this amendment:

Provides for an upward adjustment of salary schedules for certain law 1. enforcement positions in fiscal year 2016-17, instead of fiscal year 2015-16;

2. Provides one-time funding for the operation of the State's county jails and regional jail in fiscal year 2016-17, instead of fiscal year 2015-16;

3. Removes funding for the last 3 months of fiscal year 2015-16 for an increase in reimbursement rates to eligible MaineCare providers; and
