An Act To Implement the Recommendations of the Maine Affordable Housing Working Group

Reported by Representative HERBIG of Belfast for the Joint Standing Committee on Labor, Commerce, Research and Economic Development pursuant to Public Law 2015, chapter 267, Part QQQQ, section 1.

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 30-A MRSA §4753, sub-§3** is enacted to read:

3 **3. Universal application and waiting list.** The Maine State Housing Authority and
4 municipal housing authorities shall establish a single, streamlined application for tenant-
5 based rental assistance under the United States Housing Act of 1937, Public Law 412,
6 Section 8 by which families may apply for housing assistance in any geographic area of
7 the State and shall also establish a statewide, centralized waiting list for that tenant-based
8 rental assistance. The Maine State Housing Authority and municipal housing authorities
9 shall establish a method for individuals or families to submit applications and to update
10 applications for rental assistance by electronic means.

11 The Maine State Housing Authority and the Department of Health and Human Services
12 shall ensure that an application submitted pursuant to this subsection may also be used by
13 individuals and families to apply for the Bridging Rental Assistance Program established
14 in Title 34-B, section 3011 and a federal shelter plus care program authorized by the
15 federal McKinney-Vento Homeless Assistance Act, Public Law 100-77 (1987) as
16 amended by the federal Homeless Emergency Assistance and Rapid Transition to
17 Housing Act of 2009, Public Law 111-22, Division B (2009).

18 **Sec. 2. Examination of options to increase access to affordable housing**
19 **for families with incomes at or below 30% of the area median income.** To the
20 extent funds become available, the Maine State Housing Authority shall examine
21 strategies to increase access to affordable housing for persons with incomes at or below
22 30% of the area median income, including, but not limited to, increasing the accessibility
23 of new housing units built with support from the federal low-income housing tax credit
24 program for households with incomes at or below 30% of the area median income.

25 The Maine State Housing Authority shall provide a report on its progress in
26 increasing access to affordable housing pursuant to this section to the joint standing
27 committee of the Legislature having jurisdiction over labor, commerce, research and
28 economic development matters by January 15, 2019.

29 **Sec. 3. Rental assistance pilot program.** The Maine State Housing Authority
30 shall work with municipal housing authorities to identify unused vouchers under the
31 United States Department of Housing and Urban Development's Housing Choice
32 Voucher Program and use these vouchers to establish a rental assistance pilot program.
33 The Maine State Housing Authority shall design and implement the program based on
34 best practices and evidence-based research to provide a comprehensive approach to
35 prevent homelessness and promote housing stability, family well-being and self-
36 sufficiency for families at risk of homelessness.

37 The Maine State Housing Authority shall collect and maintain data sufficient to
38 evaluate the extent to which the pilot program achieves success in meeting its goals and
39 provide a report to the joint standing committee of the Legislature having jurisdiction
40 over labor, commerce, research and economic development matters by January 15, 2019.

SUMMARY

This bill, which contains the recommendations of the working group convened pursuant to Public Law 2015, chapter 267, Part QQQQ to evaluate the lack of access to affordable housing, is reported out by the Joint Standing Committee on Labor, Commerce, Research and Economic Development pursuant to that law. The bill directs the Maine State Housing Authority and municipal housing authorities to create a single, statewide application and waiting list for so-called Section 8 housing and to ensure that the application can be filled out online. The bill directs the Maine State Housing Authority and the Department of Health and Human Services to ensure that the application can be used by individuals and families to apply for the federal Shelter Plus Care program and the state Bridging Rental Assistance Program. The bill further directs the Maine State Housing Authority to examine options to increase access to affordable housing for families with incomes at or below 30% of the area median income and to establish a rental assistance pilot program.

The Joint Standing Committee on Labor, Commerce, Research and Economic Development has not taken a position on the substance of this bill and by reporting this bill out the committee is not suggesting and does not intend to suggest that it agrees or disagrees with any aspect of this bill. The committee is reporting the bill out for the sole purpose of turning the working group's recommendations into a printed bill that can be referred to the committee for an appropriate public hearing and subsequent processing in the normal course. The committee is taking this action to ensure clarity and transparency in the legislative review of the working group's recommendations.
