1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 25 MRSA §2014 is enacted to read:
3	§2014. Background checks for firearms sales and transfers
4 5	<u>1. Definitions.</u> As used in this section, the following terms have the following meanings.
6	A. "Corrections officer" has the same meaning as in section 2801-A, subsection 2.
7 8 9 10 11 12	B. "Family member" means husband, wife, domestic partner, parent by blood, parent by adoption, child by blood, child by adoption, sibling by blood, sibling by adoption, grandparent, grandchild, niece, nephew, aunt, uncle, first cousin, father-in-law, mother-in-law, son-in-law, daughter-in-law, brother-in-law, sister-in-law, stepfather, stepmother, stepson, stepdaughter, stepbrother, stepsister, half brother, half sister or intimate partner.
13	C. "Firearm" has the same meaning as in Title 17-A, section 2, subsection 12-A.
14 15	D. "Firearm dealer" means a person who holds any federal firearms license under 18 United States Code, Section 923(a) (2015).
16 17	E. "Intimate partners" means individuals in a dating relationship who are currently living with each other.
18 19	<u>F.</u> "Law enforcement agency" has the same meaning as in section 3701, subsection 1 .
20 21	<u>G.</u> "Law enforcement officer" has the same meaning as in section 3701, subsection <u>3.</u>
22 23	H. "Person" means an individual, corporation, partnership, firm, trust, organization or other legal entity.
24 25	I. "Sell" has the same meaning as in Title 17-A, section 554-A, subsection 1, paragraph C.
26 27	J. "Transfer" has the same meaning as in Title 17-A, section 554-A, subsection 1, paragraph A.
28 29	K. "Transferee" means a person who receives or intends to receive a firearm in a sale or transfer.
30 31	L. "Transferor" means a person who delivers or intends to deliver a firearm in a sale or transfer.
32 33	M. "Unlicensed person" means any person who is not a firearm dealer under this section.
34 35 36 37 38	2. Background checks required for all sales and transfers. Except as provided in subsection 8, each sale or transfer of a firearm occurring in whole or in part in this State between unlicensed persons must be preceded by a background check on the transferee, and an unlicensed person may not sell or transfer a firearm and an unlicensed person may not receive a firearm without complying with the process described in this section.

1	3. Background check conducted by firearm dealer. When both parties to a
2	prospective sale or transfer of a firearm are unlicensed persons, the transferor and
3	transferee shall meet jointly at a firearm dealer and request that the firearm dealer
4	facilitate the sale or transfer. A firearm dealer who agrees to facilitate a sale or transfer
5	under this section shall process the sale or transfer as though selling or transferring the
6	firearm from its own inventory to the transferee, complying with all requirements of
7	federal and state law that would apply if it were making such a sale or transfer, including
8	all background check and record-keeping requirements.
9	4. No sale or transfer if failed background check. Neither a firearm dealer nor a
10	transferor may deliver any firearm to a transferee if the results of the background check
11	pursuant to subsection 3 indicate that the transferee is disqualified to possess firearms
12	under state or federal law.
13	5. Leaving dealer with firearm. Notwithstanding any other provision of law:
14	A. This section does not prevent the transferor from removing the firearm from the
15	premises of the firearm dealer while a background check is being conducted pursuant
16	to subsection 3. Before the transferor sells or transfers the firearm to the transferee,
17	the parties must return to the firearm dealer, who shall take possession of the firearm
18	in order to complete the sale or transfer; and
19	B. This section does not prevent the transferor from removing the firearm from the
20	premises of the firearm dealer if the results of the background check pursuant to
21	subsection 3 indicate that the transferee is disqualified to possess firearms under state
22	or federal law.
23	6. Reasonable fee. A firearm dealer who agrees to facilitate a sale or transfer
23	pursuant to this section may charge a reasonable fee for services rendered.
25	7. Completion of forms. A transferor and a transferee must each complete, sign and
26	submit all federal and state forms necessary to process the background check and
27	otherwise complete the sale or transfer pursuant to this section.
28	8. Exceptions. The provisions of this section apply to the transfer or sale of a
29	firearm between unlicensed persons except if:
30	A. The sale or transfer is between family members;
31	B. The firearm is a curio or relic, as defined in 27 Code of Federal Regulations,
32	Section 478.11 (2015), and the sale or transfer is between collectors of firearms as
33	curios or relics, as defined by 18 United States Code, Section 921(a)(13) (2015), who
34	both have in their possession a valid collector of curios and relics license issued by
35	the federal Bureau of Alcohol, Tobacco, Firearms and Explosives;
36	<u>C.</u> The sale or transfer is of an antique firearm, as defined in 18 United States Code,
37	Section 921(a)(16) (2015);
38 39	<u>D.</u> The transfer is temporary and is necessary to prevent imminent death or great bodily harm, and:
40	(1) The transfer lasts only as long as necessary to prevent such threat; and

1 2 3	(2) The transferor has no reason to believe that the transferee is disqualified to possess firearms under state or federal law and has no reason to believe that the transferee intends to use the firearm in the commission of a crime;
4 5	E. Either the transferor or the transferee is a law enforcement agency or the Department of Corrections or is, to the extent the person is acting within the course of
6	the person's employment or official duties, a peace officer, a law enforcement officer,
7	a corrections officer, a member of the Armed Forces of the United States or the
8 9	National Guard or the Reserves of the United States Armed Forces, a federal law
10	enforcement officer or a person licensed as a security guard or employed by a contract security company or proprietary security organization under Title 32, chapter
10	<u>93:</u>
12	F. The transfer is temporary, the transferor has no reason to believe that the
13 14	transferee intends to use the firearm in the commission of a crime and the transfer and the transferee's possession of the firearm take place exclusively:
15	(1) At an established shooting range authorized by the governing body of the
16	jurisdiction in which such range is located or, if no such authorization is required,
17	operated consistently with local law in such jurisdiction;
18	(2) At a lawfully organized competition involving the use of a firearm or for
19	participation in or practice for a performance by an organized group that uses
20	firearms as a part of the performance;
21	(3) While the transferee is hunting or trapping if such activity is legal in all
22	places where the transferee possesses the firearm and the transferee holds any
23	license or permit required for such activity; or
24	(4) In the actual presence of the transferor.
25	Any transfer allowed by this paragraph is permitted only if the transferor has no
26	reason to believe that the transferee is disqualified to possess firearms under state or
27	federal law or, if the transferee is under 18 years of age and is receiving the firearm
28	under direct supervision and control of an adult, that such adult is disqualified to
29	possess firearms under state or federal law; or
30	G. The transfer occurs by operation of law upon the death of a person for whom the
31	transferee is an executor, administrator, trustee or personal representative of an estate
32	or a trust created in a will.
33	9. Violations. Any person who knowingly delivers or receives a firearm without
34	complying with this section commits:
35	A. For a first conviction involving the sale or transfer of one or more firearms, a
36	Class D crime; and
37	B. For a 2nd or subsequent conviction involving the sale or transfer of one or more
38	firearms, a Class C crime.

SUMMARY

This initiated bill requires a background check before a firearm sale or transfer 2 between individuals not licensed as firearm dealers. If neither party to a sale or transfer 3 has a federal firearms license, the parties meet at a licensed firearm dealer, who conducts 4 a background check on the transferee and completes the sale or transfer as though selling 5 6 or transferring from the dealer's own inventory. Exceptions to the background check requirement are made for transfers between family members, while the parties are 7 hunting or sport shooting, for emergency self-defense, in the presence of the transferor 8 9 and in other circumstances.
