Pursuant to the Mandate Preamble, the two-thirds vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional costs.

Fiscal Detail and Notes

The bill includes a General Fund appropriation to the Department of Secretary State of \$351,022 in fiscal year 2017-18 and \$274,715 in fiscal year 2018-19 to produce state identification cards, perform programming changes, generate provisional ballots and affidavits and conduct voter outreach.
