The Maine Public Employees Retirement System shall report twice to the joint standing committee of the Legislature having jurisdiction over 16 17 retirement matters, no later than January 31, 2019 and January 31, 2020, on the use of the authority granted to the Board of Trustees of the Maine Public Employees Retirement 18 19 System pursuant to the Maine Revised Statutes, Title 5, chapter 423, subchapter 7 and 20 Title 5, chapter 425, subchapter 7, including the results of any offering of long-term 21 disability insurance by the board.' SUMMARY 22 23 This amendment replaces the bill, which is a concept draft. 24 The amendment authorizes the Board of Trustees of the Maine Public Employees 25 Retirement System to procure and offer long-term disability insurance to the retirement system's members and employees who choose not to become members but participate in 26 27 the defined contribution plan pursuant to the Maine Revised Statutes, section 18801, subsection 1. The decision about whether to offer coverage is made by the employer. 28 29 Premiums would not be paid for by the retirement system, but would be paid by employers, by employees electing the coverage or by a combination of both. 30 The amendment also directs the retirement system to report twice to the joint standing 31 32 committee of the Legislature having jurisdiction over retirement matters on the use of the authority granted by this bill, once in 2019 and once in 2020. 33 34 FISCAL NOTE REQUIRED 35 (See attached)

Fiscal Detail and Notes

This bill authorizes the Maine Public Employees Retirement System (MainePERS) to procure and offer long-term disability insurance coverage to its members through their employers. Additional costs to MainePERS associated with the rulemaking and reporting requirements can be absorbed within existing budgeted resources. Because participation by employers is optional, there is no fiscal impact to the State, local school administrative units and local towns and municipalities that participate in the retirement system.
