15 16	'Sec. 1. 17-A MRSA §852, sub-§1, as amended by PL 2013, c. 407, §2, is further amended to read:
17	1. A person is guilty of aggravated sex trafficking if the person knowingly:
18 19	A. Promotes prostitution by compelling a person to enter into, engage in or remain in prostitution. Violation of this paragraph is a Class B crime;
20 21	B. Promotes prostitution of a person less than 18 years old. <u>Violation of this</u> paragraph is a Class A crime; or

Promotes prostitution of a person who suffers from a mental disability that is reasonably apparent or known to the actor and that in fact renders the other person substantially incapable of appraising the nature of the conduct involved. <u>Violation of this paragraph is a Class A crime.</u>
26 27	Sec. 2. 17-A MRSA §852, sub-§3, as amended by PL 2013, c. 407, §2, is repealed.'

29	This amendment is the minority report of the committee. The amendment replaces
30 31	the bill. It increases the class for the crime of aggravated sex trafficking from a Class B to a Class A grime if the person who is trafficked is loss than 18 years of aga. It increases
