1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §3174-T, sub-§2, ¶C**, as reallocated by RR 1997, c. 2, §46, is
3 amended to read:

4 C. All children resident in the State are eligible except a child who:

5 (1) Is eligible for coverage under the Medicaid program;

6 (2) Is covered under a group health insurance plan or under health insurance, as
7 defined in Section 2791 of the federal Public Health Service Act, 42 United
8 States Code, Section 300gg(c) (Supp. 1997);

9 ~~(3) Is a member of a family that is eligible under Title 5, section 285 for health~~
10 ~~coverage under the state employee health insurance program;~~

11 (4) Is an inmate in a public institution or a patient in an institution for mental
12 diseases; or

13 (5) Within the 3 months prior to application for coverage under the Cub Care
14 program, was insured or otherwise provided coverage under an employer-based
15 health plan for which the employer paid 50% or more of the cost for the child's
16 coverage, except that this subparagraph does not apply if:

17 (a) The cost to the employee of coverage for the family exceeds 10% of the
18 family's income;

19 (b) The parent lost coverage for the child because of a change in
20 employment, termination of coverage under the Consolidated Omnibus
21 Budget Reconciliation Act of 1985, COBRA, of the Employee Retirement
22 Income Security Act of 1974, as amended, 29 United States Code, Sections
23 1161 to 1168 (Supp. 1997) or termination for a reason not in the control of
24 the employee; or

25 (c) The department has determined that grounds exist for a good-cause
26 exception.

27 **SUMMARY**

28 This bill allows children of state employees to be eligible for the State Children's
29 Health Insurance Program as long as they meet the other eligibility requirements.
