12 13	Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:
14 15	'Sec. 1. 12 MRSA §6671, sub-§3, as amended by PL 2007, c. 494, §1, is further amended to read:
16 17	3. Shellfish conservation ordinance. The following provisions govern a shellfish conservation ordinance.
1 8	A. Within any area of the municipality, a shellfish conservation ordinance may:
19	(1) Regulate or prohibit the possession of shellfish;
20	(2) Fix the amount of shellfish that may be taken;
21	(3) Provide for protection from shellfish predators;
22 23	(4) Authorize the municipal officials to open and close flats under specified conditions; and
24 25 26	(5) Specify areas of the intertidal zone in which the dragging of mussels may be limited to the degree necessary to support a municipal shellfish conservation program-; and
27 28 29	(6) In accordance with paragraph D, prohibit harvesting any marine organism in a buffer zone around netting placed to provide for protection from shellfish predators pursuant to subparagraph (3).
30	B. An ordinance must limit the size of soft-shell clams in accordance with article 5.
31 32 33	C. Except as provided in section 6621, subsection 3, paragraph C, a program or ordinance may not allow surveying, sampling or harvesting of shellfish in areas closed by regulation of the commissioner

SUMMARY

This amendment replaces the bill, which allows municipalities to designate conservation areas where harvesting any marine organism is prohibited. The amendment instead provides that a municipal shellfish ordinance may prohibit harvesting any marine organism in a buffer zone around netting placed for protection from shellfish predators, as long as the buffer zone does not exceed 5 feet between any 2 nets and 20 feet around the outermost perimeter of a net or multiple nets when those nets are placed within 5 feet of each other.
