COMMITTEE OF CONFERENCE AMENDMENT "A" to COMMITTEE AMENDMENT "C" to H.P. 281, L.D. 390, Bill, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2018 and June 30, 2019"

Amend the amendment by striking out everything after Part B and before the summary and inserting the following:

'PART C

Sec. C-1. 8 MRSA §1036, sub-§2-A, ¶A, as enacted by IB 2009, c. 2, §45, is amended to read:

A. Twenty-five percent of the net slot machine income must be forwarded directly by the board to the Treasurer of State, who shall credit the money to the Department of Education, to be used to supplement and not to supplant funding for essential programs and services for kindergarten to grade 12 under Title 20-A, chapter 606-B;

Sec. C-2. 8 MRSA §1036, sub-§2-B, ¶A, as enacted by IB 2009, c. 2, §46, is amended to read:

A. Ten percent of the net table game income must be forwarded directly by the board to the Treasurer of State, who shall credit the money to the Department of Education, to be used to supplement and not to supplant funding for essential programs and services for kindergarten to grade 12 under Title 20-A, chapter 606-B;

- 7 (3) An approval process for an existing member to transfer to another school
8 management and leadership center;
- 9 (4) The process for determining the sharing of costs for and the assessments of
10 or payments to the school management and leadership center;
- 11 (5) The budget process that requires a school management and leadership center
12 budget be adopted by a date established in order to meet local school
13 administrative unit budget deadlines. The budget process must include a
14 contingency plan for a budget failure and must be in the cost center summary
15 budget format pursuant to section 1485;
- 16 (6) The process for a balanced budget as required by section 3802, subsection 10
17 and the method of determining the return of any excess funds to the members of
18 the school management and leadership center; and
- 19 (7) The process for the disposition of indebtedness and property including by
20 sale or lease, transferred to or from or administered by the school management
21 and leadership center.
- 22 B. An interlocal agreement may include but is not limited to a description of the
23 following:
- 24 (1) The approval process for the formation of a school management and
25 leadership center;
- 26 (2) Any associate members, the process for including associate members and
27 their roles in the school management and leadership center;
- 28 (3) The process to authorize the school management and leadership center to
29 borrow funds for school construction purposes including bonds and notes;
- 30 (4) The process to approve the purchase or lease of buildings or land by the
31 school management and leadership center;
- 32 (5) The process by which a school management and leadership center may
33 establish, maintain and expend funds from a reserve fund or contingency fund;
- 34 (6) The process of hiring an executive director for the school management and
35 leadership center; and
- 36 (7) A transition plan to move authorized programs and services from a member
37 to the school management and leadership center.

1 An interlocal agreement cannot transfer a school administrative unit's responsibility for

5 **4. Duties of school management and leadership center.** A school management
6 and leadership center's functions, programs and services may include but are not limited

11 D. Special education programs and administration;

17 J. Energy management and facilities maintenance;

18 K. Regional school leadership academies;

19 L. Staff training and professional development;

21 N. Shared support service programs;

22 O. Educational programs such as summer school, extended school year, tutoring,
23 advanced placement and other programs that serve students and improve student
24 achievement;

25 P. Shared extracurricular or cocurricular programs; and

26 Q. Superintendent services.

27 **§3802. School management and leadership center authorized**

28 A school management and leadership center shall provide administrative and
29 education functions in accordance with this chapter and shall function as an extension of
30 the member school administrative units and associate members of the school management
31 and leadership center. A member school administrative unit of the school management
32 and leadership center cannot transfer the responsibility for providing the opportunity of a
33 free public education to each of its students or a free, appropriate education to each of its
34 students with a disability as required by this Title or by federal law.

35 **1. Geographic boundaries.** The commissioner shall determine 9 to 12 geographic
36 areas for the establishment of each school management and leadership center.
37 Membership in a particular school management and leadership center does not require the

1 member to be physically located in the school management and leadership center's

3 **2. Members.** Members in a school management and leadership center must be
4 determined by interlocal agreement pursuant to Title 30-A, chapter 115 and may include
5 the following types of school administrative units:

6 A. Community school districts pursuant to chapter 105;

7 B. Municipal school units pursuant to chapter 111;

8 C. Regional school units pursuant to chapter 103-A;

9 D. School administrative districts pursuant to chapter 103; and

10 E. Schools established on tribal lands pursuant to Title 30, chapter 601.

11 **3. Associate members.** Associate members for a school management and leadership
12 center may include the following through a contractual agreement or memorandum of
13 understanding with the members of the school management and leadership center:

14 A. Career and technical education regions pursuant to chapter 313, subchapter 4;

15 B. Public charter schools as defined in chapter 112;

16 C. Providers of child development services pursuant to chapter 303;

17 D. Magnet schools pursuant to chapters 312 and 312-A;

18 E. The Maine Educational Center for the Deaf and Hard of Hearing and the
19 Governor Baxter School for the Deaf pursuant to chapter 304;

20 F. Providers of education in the unorganized territory pursuant to chapter 119; or

21 G. Municipalities and counties pursuant to Title 30-A.

22 **4. Provision of services to or from other public entities or nonprofit entities.** A
23 school management and leadership center may provide services to or purchase services
24 from other types of political subdivisions, public entities or nonprofit organizations or
25 associations.

26 **5. Purchase of services from another school management and leadership center.**
27 A member of a school management and leadership center may purchase services from
28 another school management and leadership center if not provided by the member's school
29 management and leadership center.

30 **6. Validation.** A school management and leadership center authorized and
31 organized under this chapter is validated, confirmed, approved and declared legal in all
32 respects, notwithstanding any defect or irregularity that may have occurred in the
33 organization of the school management and leadership center or in the selection of the
34 board of that school management and leadership center.

35 **7. Political subdivision.** A school management and leadership center is a political
36 subdivision within the meaning of Title 5, section 19002, subsection 6 and a quasi-
37 municipal corporation within the meaning of Title 30-A, section 5701, and all the
38 provisions of those sections apply to it. Notwithstanding Title 30-A, section 2203,

1 subsection 8, paragraph B, the members of a school management and leadership center
2 may delegate eminent domain power to the school management and leadership center by
3 agreement. A school management and leadership center is considered a tax-exempt
4 governmental entity for the purposes of Title 36, section 1760, subsection 2.

5 **8. Executive director.** A school management and leadership center shall employ an
6 executive director, and the interlocal agreement under section 3801, subsection 3 must
7 specify that the executive director shall administer, in compliance with this chapter, the
8 provisions of the interlocal agreement in the school management and leadership center.

9 **9. Personnel.** The executive director of a school management and leadership center
10 may employ a chief financial officer and may employ additional staff necessary to
11 administer the functions assigned to the school management and leadership center
12 through the provisions of the interlocal agreement under section 3801, subsection 3.

13 **10. Balanced budget.** A school management and leadership center must have a
14 balanced budget and return excess funds to the members as prescribed by the interlocal
15 agreement under section 3801, subsection 3.

16 **11. Authority to borrow, expend and accept funds.** A school management and
17 leadership center may:

18 A. Borrow funds in anticipation of a member's payment of its share of the school
19 management and leadership center budget. Such borrowing:

20 (1) Must be repaid within one year; and

21 (2) May not at any time exceed 3/4 of the school management and leadership
22 center's annual approved budget;

23 B. Expend available funds to pay debt service, security and maintenance costs; and

24 C. Accept and expend funds from state, federal and other sources and expend those
25 funds on behalf of the members.

26 **12. Bonding authority.** A school management and leadership center may issue
27 bonds and notes for school construction purposes. For purposes of this section, "school
28 construction purposes" includes minor capital costs relating to maintenance of a school's
29 physical plant. The school management and leadership center board shall decide whether
30 the issuance of bonds or notes by the school management and leadership center for school
31 construction purposes is necessary. The board shall determine whether the issuance of
32 bonds or notes is authorized, and, if so, the board shall issue the bonds or notes and
33 administer the proceeds of, and the payment of principal of and interest on, those bonds
34 or notes after issuance. A school management and leadership center may issue bonds and
35 notes for school construction purposes only under the provisions of the interlocal
36 agreement under section 3801, subsection 3.

37 **13. Withdrawal from school management and leadership center.** If a single
38 school administrative unit applies to withdraw, it must demonstrate to the commissioner
39 that as a result of the school administrative unit's withdrawing that there will be no
40 increase in costs or decrease in student programs and services for the withdrawing school

1 administrative unit and for any of the remaining member school administrative units of
2 the school management and leadership center.

3 **14. Dissolution of school management and leadership center.** A school
4 management and leadership center may not be dissolved unless it applies to the
5 commissioner for approval and:

6 A. All member school administrative units apply to transfer to another school

19 **1. Data collection; monitoring.** The commissioner or the commissioner's designee
20 is responsible for collecting, analyzing and reporting data from school management and
21 leadership centers. The commissioner or the commissioner's designee shall monitor the
22 performance and legal compliance of the school management and leadership centers,
23 including collecting and analyzing data to support ongoing evaluation of the school

25 **2. Notification of unsatisfactory performance or compliance.** If a school
26 management and leadership center's performance or legal compliance appears
27 unsatisfactory, the commissioner shall promptly provide written notice to the school

30 problems. The school management and leadership center shall provide the commissioner
31 a corrective action plan to remedy the problems.

33 A school management and leadership center shall adhere to generally accepted
34 accounting principles and shall annually engage an external auditor to do an independent
35 audit of the school management and leadership center's finances. The school management
36 and leadership center shall submit the audit to its members and to the department. The
37 audit must be conducted in the same manner as a school administrative unit audit in
38 accordance with chapter 221, subchapter 2.

1 **§3805. Application for and approval of a school management and leadership center**

2 **1. Application.** The commissioner shall establish an application process under this
3 chapter for the formation of a school management and leadership center. The application
4 must be in a form and contain such information as required by the commissioner,
5 including, but not limited to:

6 A. The identification of the school administrative units that are applying to form the
7 school management and leadership center;

8 B. The specified structure and governance of the school management and leadership

18 leadership center is approved pursuant to this chapter. The commissioner shall keep a
19 register of school management and leadership centers that have been approved pursuant
20 to this chapter.

21 **3. Voter approval.** If the commissioner approves an application for a school
22 management and leadership center pursuant to subsection 2, the school management and
23 leadership center must receive voter approval using the process specified in the interlocal
24 agreement pursuant to section 3801, subsection 3, paragraph B, subparagraph (1).

25 **§3806. Direct state funding of a school management and leadership center**

26 A school management and leadership center receives direct state funds for start-up
27 costs in accordance with section 15689, subsection 9. A school management and
28 leadership center that provides to members at least 2 different services covering a total of
29 at least 2 different categories as specified in section 15683-C, subsection 2 must receive
30 annual support for 55% of the executive director’s salary and benefits, an accounting and
31 payroll system and a student information system.

32 The school administrative units that are members of a school management and
33 leadership center must receive state funds in accordance with section 15683-C.

34 **§3807. Regional school leadership academies**

35 A regional school leadership academy is a professional development consortium that
36 combines state and local programs and resources, including the preparation, licensure,
37 certification, professional development and training for educational leadership, into a
38 coherent system that can significantly improve the recruitment and preparation of
39 prospective candidates for school principals and other school leadership positions, as well

A recipient of services may not experience a reduction in hours solely as a result of increased reimbursement.

24 for implementation in the 2017-2018 school year.

25 3. It provides statutory changes to the Essential Programs and Services Funding Act
26 for implementation in the 2018-2019 school year.

27 4. It provides statutory changes for the funding of the Maine School for Marine
28 Science, Technology, Transportation and Engineering.

29 5. It directs the Commissioner of Education to review models for state support for
30 direct instruction and equitable teacher compensation, review other components of the
31 school funding model and review system administration allocations. Following these
32 reviews, the commissioner is directed to report findings and recommendations to the joint

PART D

This Part eliminates, for tax years beginning in 2017 or after, the 3% income tax surcharge imposed on taxable income in excess of \$200,000 and eliminates the Fund to Advance Public Kindergarten to Grade 12 Education since the source of that fund is the 3% income tax surcharge.

PART E

This Part increases the sales tax on lodging from 9% to 10.5% beginning October 1, 2017 and amends the provision of law regarding transfers to the Tourism Marketing Promotion Fund to reflect the increase in the lodging tax.

PART G

Under current law, the homestead property tax exemption for property tax years beginning on or after April 1, 2017 increased by \$5,000 to \$20,000 and the percentage of state reimbursement to municipalities for property taxes lost as a result of the exemption increased from 50% to 62.5%. This Part delays the increase in the state reimbursement amount until property tax years beginning on or after April 1, 2018.

PART N

This Part makes the following changes to the laws governing the Consensus Economic Forecasting Commission.

1. It allows the terms of commission members to be staggered.
2. It changes reporting requirements to conform to current practice and adds a requirement that at least 2 economic forecasts assuming potential economic recession scenarios be provided no later than February 1st in even-numbered years.
3. It changes the required number of meetings of the commission and the Revenue Forecasting Committee from 4 a year to 3.
4. It adds a requirement that the commission and the committee jointly issue a report to the Governor, the Legislative Council and the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs that uses the potential economic recession scenarios.

PART O

This Part transfers responsibility for the supervision and administrative control of risk management insurance, claims and loss control for the State from the Director of the Bureau of General Services and the Bureau of General Services to the State Controller and the Office of the State Controller.

This Part also provides that the risk management division assists the State Controller in carrying out these duties and that the division is transferred from the Bureau of General Services to the Office of the State Controller.

PART P

This Part authorizes the Department of Administrative and Financial Services, Bureau of General Services to accept contributions from public and private sources for the maintenance, repair and construction of state facilities and provides that any earnings credited to the appropriate fund be used for the same purposes.

PART Q

This Part directs the Revisor of Statutes, when updating the Maine Revised Statutes, to change the name of the "displaced homemaker program" to the "New Ventures Maine program" and the name of the "Displaced Homemakers Advisory Council" to the "New Ventures Maine Advisory Council." This Part also changes the name of the Maine Centers for Women, Work and Community program to the New Ventures Maine program to reflect the name currently used by the University of Maine System.

PART S

This Part continues authorization for each individual tax expenditure provided by statute.

PART T

This Part authorizes the State Tax Assessor to implement a training program to develop the expertise of revenue agents and property appraisers. Upon successful completion of the program and demonstration of prescribed competencies, employees in these classifications may immediately progress to the senior position in the respective classification series.

PART V

This Part increases the cap on the year-to-year increase that counties may charge municipalities for correctional services. The cap is increased to the lower of the base assessment limit, as adjusted, and 4%; current law specifies the lower of the base assessment limit, as adjusted, and 3%.

This Part requires the State Controller to transfer \$12,202,104 from the unappropriated surplus of the General Fund to the Department of Corrections, Reserve for County Jail Operations program, Other Special Revenue Funds and stipulates that the funds may not be transferred out of the Reserve for County Jail Operations program without legislative approval.

PART X

This Part recognizes an increase in the attrition rate to 5% for the 2018-2019 biennium for judicial branch and executive branch departments and agencies and removes the attrition requirement for the District Attorneys Salaries program for the 2018-2019 biennium. This Part also requires the State Budget Officer to submit a report of the savings calculations and transfers to the Joint Standing Committee on Appropriations and Financial Affairs by September 1, 2018.

PART Y

This Part authorizes the Department of Administrative and Financial Services to enter into financing agreements in fiscal years 2017-18 and 2018-19 for the acquisition of motor vehicles for the Central Fleet Management Division within the department's Bureau of General Services.

PART Z

This Part authorizes the Department of Administrative and Financial Services to enter into financing agreements in fiscal years 2017-18 and 2018-19 for the acquisition of motor vehicles for the Department of Public Safety, Bureau of State Police.

PART AA

This Part authorizes the Department of Administrative and Financial Services to enter into financing arrangements on or after July 1, 2017 for improvements to the State's technology infrastructure and software. The agreements are limited to a principal cost of \$21,000,000 and a 6% interest rate and cannot exceed 7 years in duration.

PART CC

This Part continues the voluntary employee incentive program through the 2018-2019 biennium.

PART DD

This Part authorizes the Department of Administrative and Financial Services to identify positions to eliminate as the result of ongoing reorganizations due to efficiencies associated with the implementation of a new human resources and payroll system.

PART EE

This Part requires a review of vacant positions, regardless of fund source, in executive branch departments and agencies and authorizes position eliminations to achieve General Fund savings of \$1,500,000 in fiscal year 2018-19.

PART FF

This Part authorizes the Maine Governmental Facilities Authority to issue additional securities up to an amount of \$30,000,000 to pay for the costs of capital repairs and improvements to state-owned facilities and hazardous waste cleanup on state-owned properties.

PART GG

This Part does the following.

1. It requires the Commissioner of Administrative and Financial Services to prepare long-range economic projections and conduct studies and continuing economic analyses of the state economy.
2. It expands the mission of the Governor's Office of Policy and Management to include facilitating the achievement of all long-term state goals rather than only economic goals as in current law.
3. It repeals requirements that the Governor's Office of Policy and Management prepare long-range economic projections and conduct studies and continuing economic analyses of the state economy.
4. It repeals the requirement that the Governor's Office of Policy and Management assess and report on progress made by the State, municipalities, counties and school administrative units in achieving tax burden goals.

PART II

This Part directs the State Controller to transfer the remaining balance in the Rural Rehabilitation program, Other Special Revenue Funds account within the Department of Agriculture, Conservation and Forestry to a fund within the department's Division of

1 Quality Assurance and Regulation program, which this amendment renames the Bureau
2 of Agriculture program. It also moves the department's Rural Rehabilitation Operating
3 Fund to the Bureau of Agriculture program.

4 **PART JJ**

5 This Part moves the Other Special Revenue Funds accounts of the Agricultural Fair
6 Support Fund, Sire Stakes Fund, fund to supplement harness racing purses, Fund to
7 Encourage Racing at Maine's Commercial Tracks and Fund to Stabilize Off-track Betting
8 Facilities to the Other Special Revenue Funds operating account in the Harness Racing
9 Commission program in the Department of Agriculture, Conservation and Forestry.

10 **PART KK**

11 This Part directs the State Controller to transfer remaining balances in funds within
12 the Division of Animal Health and Industry program within the Department of
13 Agriculture, Conservation and Forestry to funds within the department's Division of
14 Quality Assurance and Regulation program, which this amendment renames the Bureau
15 of Agriculture program. It also moves the department's Agricultural Complaint Response
16 Fund, Potato Cull Removal Fund, Cattle Health Assurance Program Fund, Animal
17 Industry Fund, State of Maine Animal Response Team Fund and Nutrient Management
18 Fund to the Bureau of Agriculture program.

19 **PART LL**

20 This Part moves the Maine Mosquito Management Fund, Integrated Pest
21 Management Fund and Maine Pesticide Education Fund within the Department of
22 Agriculture, Conservation and Forestry to the department's Board of Pesticides Control
23 program. It also directs the State Controller to transfer any remaining balance in the
24 Maine Mosquito Management Fund program, Other Special Revenue Funds to the Board
25 of Pesticides Control program, Other Special Revenue Funds.

26 **PART MM**

27 This Part moves the Department of Agriculture, Conservation and Forestry's
28 agricultural development fund to the Bureau of Agriculture program within the
29 department.

30 **PART NN**

31 This Part moves the Agricultural Water Management and Irrigation Fund within the
32 Department of Agriculture, Conservation and Forestry to the department's Bureau of
33 Agriculture program. It also directs the State Controller to transfer remaining balances in
34 funds within the Division of Agricultural Resource Development program to funds within
35 the Division of Quality Assurance and Regulation program, which this amendment
36 renames the Bureau of Agriculture program.

37 **PART OO**

38 This Part moves the Maine Milk Commission's Dairy Industry Fund to the Milk
39 Commission program in the Department of Agriculture, Conservation and Forestry.

40 **PART PP**

1 This Part moves the Department of Agriculture, Conservation and Forestry's animal
2 welfare auxiliary fund to the Animal Welfare Fund program.

3 **PART QQ**

4 This Part eliminates the Maine Coastal Program in the Department of Agriculture,
5 Conservation and Forestry and authorizes the Commissioner of Marine Resources to
6 manage and coordinate the implementation of a state coastal zone management program.
7 This Part also directs the State Controller to transfer remaining balances at the end of
8 fiscal year 2016-17 from the Maine Coastal Program in the Department of Agriculture,
9 Conservation and Forestry to the Department of Marine Resources, Bureau of Policy and
10 Management program.

11 **PART SS**

12 This Part eliminates one Ranger Pilot position in the forest protection unit of the
13 Department of Agriculture, Conservation and Forestry, Bureau of Forestry.

14 **PART TT**

15 This Part changes the conservation easement registry fee from \$30 to \$80.

16 **PART UU**

17 This Part transfers any remaining balance in the Federal Expenditures Fund and
18 Other Special Revenue Funds in the Division of Plant Industry program in the
19 Department of Agriculture, Conservation and Forestry to the Division of Quality
20 Assurance and Regulation program.

21 **PART VV**

22 This Part renames the Forest Health and Monitoring program within the Department
23 of Agriculture, Conservation and Forestry the Forest Resource Management program.

24 **PART WW**

25 This Part renames the Division of Quality Assurance and Regulation program within
26 the Department of Agriculture, Conservation and Forestry the Bureau of Agriculture
27 program.

28 **PART XX**

29 This Part renames the Coastal Island Registry program within the Department of
30 Agriculture, Conservation and Forestry the Submerged Lands and Island Registry
31 program.

32 **PART YY**

33 This Part directs the State Controller to lapse \$435,088 of unencumbered balance
34 forward in the All Other line category in the Maine Farms for the Future Program,
35 General Fund account in the Department of Agriculture, Conservation and Forestry to the
36 General Fund unappropriated surplus no later than July 31, 2017.

37 **PART ZZ**

1 This Part directs the State Controller to lapse \$1,000,000 of unencumbered balance
2 forward in the Personal Services line category in the Division of Forest Protection
3 program, General Fund account in the Department of Agriculture, Conservation and
4 Forestry to the General Fund unappropriated surplus no later than July 31, 2017.

5 **PART AAA**

6 This Part directs the State Controller to transfer \$58,047 from the Department of
7 Agriculture, Conservation and Forestry, Beverage Container Enforcement Fund program,
8 Other Special Revenue Funds account to the General Fund unappropriated surplus no
9 later than August 30, 2017.

10 **PART BBB**

11 This Part requires the State Controller to transfer \$500,000 from available balances in
12 Other Special Revenue Funds accounts in the Department of Agriculture, Conservation
13 and Forestry to the General Fund unappropriated surplus at the end of fiscal year
14 2017-18. It requires the Commissioner of Agriculture, Conservation and Forestry to
15 determine prior to June 30, 2018 the Other Special Revenue Funds accounts from which
16 the funds must be transferred, excluding the Public Reserved Lands Management Fund.

17 **PART CCC**

18 This Part adds law enforcement officials in the Office of Chief Medical Examiner,
19 the investigation division and the Medicaid fraud control unit within the Office of the
20 Attorney General to the list of law enforcement officials authorized to use assigned state-
21 owned vehicles to commute between home and work.

22 **PART DDD**

23 This Part authorizes the Attorney General to set the compensation of the Deputy
24 Chief Medical Examiner in consultation with the Chief Medical Examiner and with the
25 approval of the Governor.

26 This Part also removes the specific salary schedule reference for the Deputy Chief
27 Medical Examiner, as this is the only unclassified, confidential position on the medical
28 personnel salary schedule.

29 **PART EEE**

30 This Part increases the maximum fee allowed to be paid to nonsalaried medical
31 examiners and nonsalaried medicolegal death investigators for an inspection and view.

32 **PART FFF**

33 This Part increases the fees charged by the Department of the Attorney General,
34 Office of Chief Medical Examiner for providing report documents and histological slides.

35 **PART GGG**

36 This Part increases the fee charged by a medical examiner for a certificate that is
37 required for cremation and allows this fee to be waived at the discretion of the Chief
38 Medical Examiner.

39 **PART HHH**

1 This Part renames the Audit - Departmental Bureau program the Audit Bureau
2 program to align the program name with the agency name, which was changed from the
3 Department of Audit to the Office of the State Auditor pursuant to Public Law 2013,
4 chapter 16.

5 **PART III**

6 This Part renames the Audit - Unorganized Territory program the Unorganized
7 Territory program to align the program name with the agency name, which was changed
8 pursuant to Public Law 2013, chapter 16 from the Department of Audit to the Office of
9 the State Auditor.

10 **PART JJJ**

11 This Part allows the Department of Corrections to carry unexpended Personal
12 Services balances to the Capital Expenditures line category in the Capital
13 Construction/Repairs/Improvements - Corrections program within the department
14 beginning at the close of fiscal year 2017-18.

15 **PART KKK**

16 This Part directs the Commissioner of Corrections to review the current
17 organizational structure of the Department of Corrections to improve organizational
18 efficiency and cost-effectiveness and directs the State Budget Officer to transfer positions
19 and available balances by financial order. The transfers must be made during the period
20 from July 1st to December 1st of each fiscal year in the 2018-2019 biennium to be
21 considered an adjustment to position count or appropriations. Any transfers resulting in a
22 program or mission change or facility closure must have legislative review.

23 **PART LLL**

24 This Part authorizes the Department of Corrections to transfer, by financial order,
25 Personal Services, All Other or Capital Expenditures funding between accounts within
26 the same fund for the purpose of paying departmental overtime expenses in fiscal years
27 2017-18 and 2018-19.

28 **PART MMM**

29 This Part requires the State Controller to lapse \$1,644,985 from the Prisoner
30 Boarding - Carrying account within the Department of Corrections in fiscal year 2017-18
31 to the General Fund unappropriated surplus.

32 **PART NNN**

33 This Part requires the State Controller to transfer \$68,163 from the Maine
34 Microenterprise Initiative Fund program, Other Special Revenue Funds account in the
35 Department of Economic and Community Development to the unappropriated surplus of
36 the General Fund by the close of fiscal year 2017-18.

37 **PART OOO**

38 This Part requires the State Controller to transfer \$78 from the Economic Opportunity
39 program, Other Special Revenue Funds account within the Department of Economic and

1 Community Development to the unappropriated surplus of the General Fund by the end
2 of fiscal year 2017-18.

3 **PART PPP**

4 This Part requires the State Controller to transfer \$2,765 from the Job Retention
5 Program, Other Special Revenue Funds account within the Department of Economic and
6 Community Development to the unappropriated surplus of the General Fund by June 30,
7 2018.

8 **PART QQQ**

9 This Part changes an appointed position's title from Science, Technology,
10 Engineering and Mathematics Workforce Coordinator to Director of Special Projects.

11 **PART RRR**

12 This Part eliminates the requirement that the Policy Director of Special Services in
13 the Department of Education supervise the school nurse consultant position.

14 **PART SSS**

15 This Part authorizes the Commissioner of Education's designee to appoint and
16 supervise a director of early childhood special education.

17 **PART UUU**

18 This Part directs the State Controller to transfer \$5,000,000 no later than June 30,
19 2018, as a one-time transfer, from the General Fund unappropriated surplus to the Fund
20 for Efficient Delivery of Educational Services, Other Special Revenue Funds account
21 within the Department of Education.

22 **PART VVV**

23 This Part authorizes the Department of Education to enter into lease-purchase
24 agreements for portable learning devices and support systems for students and educators
25 in fiscal years 2017-18 and 2018-19.

26 **PART WWW**

27 This Part authorizes the Maine Health Data Organization to transfer available
28 Personal Services balances up to a specified amount by financial order to the All Other
29 line category in the Maine Health Data Organization, Other Special Revenue Funds
30 account during the 2018-2019 biennium.

31 **PART AAAA**

32 This Part eliminates the Bone Marrow Screening Fund within the Department of
33 Health and Human Services. This Part also eliminates the ability of an individual to
34 designate a portion of that individual's income tax refund for the Bone Marrow Screening
35 Fund.

36 **PART BBBB**

37 This Part repeals the law establishing the Comprehensive Cancer Screening,
38 Detection and Prevention Fund within the Department of Health and Human Services.

PART CCCC

This Part reassigns the application fee for a retail tobacco license that is now deposited in the General Fund to the Health Inspection Program account, which is an Other Special Revenue Funds account in the Department of Health and Human Services, Maine Center for Disease Control and Prevention, to cover the costs of administering licensing for tobacco retailers.

PART DDDD

This Part eliminates the Maine Asthma and Lung Disease Research Fund within the Department of Health and Human Services. This Part also eliminates the ability of an individual to designate a portion of the individual's income tax refund for the Maine Asthma and Lung Disease Research Fund.

PART IIII

This Part specifies that the base year for the hospital tax is 2014.

PART LLLL

This Part contains transition provisions for the consolidation of accounts from the Department of Health and Human Services, formerly the Department of Behavioral and Developmental Services, to the Department of Health and Human Services.

PART MMMM

This Part authorizes the Department of Health and Human Services to transfer available balances of appropriations between the MaineCare General Fund accounts for both fiscal years of the 2018-2019 biennium.

PART NNNN

This Part does the following.

1. It authorizes the Department of Health and Human Services to transfer by financial order certain available appropriations, including those in Personal Services, among MaineCare, MaineCare-related and non-MaineCare-related accounts.
2. It authorizes the Department of Health and Human Services to transfer by financial order available Personal Services balances in the Disproportionate Share - Dorothea Dix Psychiatric Center program, the Disproportionate Share - Riverview Psychiatric Center program and the Riverview Psychiatric Center program to the All Other line category of those programs in order to provide flexibility in the payment of operational expenses.

PART OOOO

This Part eliminates, beginning July 1, 2019, the authority of the Department of Health and Human Services to transfer dedicated family support services funds between the Developmental Services - Community program and the Office of Aging and Disability Services Central Office program and Long Term Care - Office of Aging and Disability Services program.

PART PPPP

1 This Part authorizes the transfer of available Personal Services or All Other balances
2 from the Department of Health and Human Services, Developmental Services -
3 Community program to the Crisis Outreach Program for the 2018-2019 biennium.

4 **PART QQQQ**

5 This Part authorizes the Department of Health and Human Services to transfer
6 appropriations within the Office of Child and Family Services related to the cost of
7 administering the child welfare program.

8 **PART RRRR**

9 This Part renames the Office of the Commissioner program within the Department of
10 Health and Human Services the Department of Health and Human Services Central
11 Operations program.

12 **PART SSSS**

13 This Part renames the Division of Licensing and Regulatory Services program within
14 the Department of Health and Human Services the Division of Licensing and
15 Certification program.

16 **PART TTTT**

17 This Part gives the Department of Health and Human Services the authority to adopt
18 emergency rules to implement any provisions of this bill over which it has specific
19 authority that has not been addressed by some other Part of the bill without the necessity
20 of demonstrating that immediate adoption is necessary to avoid a threat to public health,
21 safety or welfare.

22 **PART UUUU**

23 This Part amends the laws governing the Maine Commission on Indigent Legal
24 Services. It requires the eligibility standards developed by the commission to take into
25 account the ability of a person to make periodic installment payments toward counsel
26 fees. It requires the commission, at least every 5 years, to review the standards for
27 evaluating counsel. It modifies and adds to the duties of the commission. It specifies that
28 the executive director of the commission may contract for personnel. It provides that
29 non-General Fund funds received by the commission do not lapse at the end of the fiscal
30 year. It requires the executive director of the commission to establish procedures to
31 verify and review the eligibility of persons for indigent legal services and requires the
32 executive director to provide the court information used to determine indigency for
33 guidance to the court in determining a person's financial ability to obtain private counsel.
34 It provides for reimbursement and installment payments for persons determined by the
35 court to be able to contribute to payment of assigned or contract counsel. It exempts from
36 the prohibition on disclosing tax information the disclosure to the commission of tax
37 information for the purpose of determining the eligibility for indigent legal services and
38 the ability to reimburse expenses incurred by counsel.

39 This Part requires the State Controller to transfer \$19,205,270 from the
40 unappropriated surplus of the General Fund to the Maine Commission on Indigent Legal
41 Services, Reserve for Indigent Legal Services program, Other Special Revenue Funds and

1 stipulates that funds may not be transferred out of the Reserve for Indigent Legal Services
2 program without legislative approval.

3 This Part also establishes the Working Group to Improve the Provision of Indigent
4 Legal Services. The working group consist of 11 members including 2 Senators and 2
5 members of the House of Representatives. The other members represent the other
6 stakeholders, including 2 appointed by the Chief Justice of the Supreme Judicial Court.
7 Notwithstanding any other provision of law, the working group may access data
8 maintained by the Maine Commission on Indigent Legal Services and shall maintain the
9 confidentiality of any confidential information provided to the working group. The
10 working group may invite the participation and input of additional interested parties and
11 request information as necessary to carry out its duties.

12 The working group must submit a report, including recommendations, by December
13 6, 2017. The Joint Standing Committee on Judiciary may report out legislation to the
14 Second Regular Session of the 128th Legislature.

15 **PART VVVV**

16 This Part delays the funding of the Fiscal Stability Program until the 2020-2021
17 biennial budget.

18 **PART WWWW**

19 This Part directs the State Controller to transfer funds from the Inland Fisheries and
20 Wildlife Carrying Balances - General Fund account to the Enforcement Operations -
21 Inland Fisheries and Wildlife program, General Fund account to purchase one
22 replacement aircraft engine in fiscal year 2017-18 and one replacement aircraft engine in
23 fiscal year 2018-19.

24 **PART XXXX**

25 This Part increases compensation of active retired judges and justices of the state
26 courts from \$300 per day to \$350 per day and from \$175 per 1/2 day to \$200 per 1/2 day.

27 This Part also provides for a raise of 3% for judges and justices of the state courts for
28 both fiscal year 2017-18 and fiscal year 2018-19.

29 **PART YYYY**

30 This Part clarifies that the record search fee schedule established by the State Court
31 Administrator is for those record searches performed by Judicial Department employees
32 and specifies that the record search fees deposited into the fund for use by the State Court
33 Administrator to fund publications, forms and information technology are those fees for
34 record searches performed by Judicial Department employees.

35 This Part also allows the Supreme Judicial Court to raise or establish fees on online
36 electronic case searches performed by Judicial Department employees, document delivery
37 and case filings and surcharges on fines for the purpose of paying the cost of maintaining
38 an electronic filing and court information management system.

39 **PART ZZZZ**

1 This Part provides that the members of the Maine Unemployment Insurance
2 Commission must be sworn and may be removed by the Governor for inefficiency,
3 willful neglect of duty or malfeasance in office, but only with the review and concurrence
4 of the joint standing committee of the Legislature having jurisdiction over labor matters
5 upon hearing in executive session or by impeachment. Before removing a commission
6 member, the Governor shall notify the President of the Senate and the Speaker of the
7 House of Representatives of the removal and the reasons for the removal.

8 **PART AAAAA**

9 This Part moves the original jurisdiction of employer unemployment appeals cases
10 from the Maine Unemployment Insurance Commission, the members of which are
11 appointed by the Governor, to the Department of Labor, Bureau of Unemployment
12 Compensation, Division of Administrative Hearings to conform with federal law.

13 This Part also revises the law to comply with Section 303(a)(3) of the federal Social
14 Security Act, which requires that the first level of appeals hearings must be conducted by
15 a merit-staffed governmental employee in order to meet the impartial hearing requirement
16 of Section 303(a)(3). For the purposes of this provision, "merit-staffed" means that the
17 individuals are subject to personnel standards based on a merit system and are not
18 political appointees.

19 **PART BBBBB**

20 This Part repeals the provision of law that prohibits any unencumbered balance in the
21 Competitive Skills Scholarship Fund from being used for a different purpose without
22 legislative approval.

23 **PART CCCCC**

24 Section 1 of the Part changes the weekly benefit subtraction factor for partial
25 unemployment from \$25 to \$100 to incentivize reemployment and connection to the
26 workforce.

27 The remainder of this Part changes the experience rating and the lowest tax schedule
28 to make Maine unemployment tax rates more equitable. The chargeability of benefit
29 charges is revenue neutral.

30 **PART DDDDD**

31 This Part directs the Commissioner of Labor to identify positions to eliminate in the
32 Department of Labor as the result of ongoing reorganizations and report to the joint
33 standing committee of the Legislature having jurisdiction over labor matters. The
34 committee is authorized to report out legislation regarding the recommendations to the
35 First Regular Session of the 129th Legislature.

36 **PART EEEEE**

37 This Part separates the fees for each license issued by the Department of Marine
38 Resources into a license fee and a surcharge fee that accrues to a specific fund. This Part
39 directs 30% of the license fees imposed pursuant to the Maine Revised Statutes, Title 12,
40 Part 9 into the Coastal Fisheries, Research Management and Opportunity Fund, which is

1 established to fund scientific research, management or enforcement activities related to
2 marine resources.

3 **PART FFFFF**

4 This Part renames the Board of Registration for Professional Engineers program
5 within the Department of Professional and Financial Regulation the State Board of
6 Licensure for Professional Engineers program.

7 **PART IIIII**

8 This Part provides that the Executive Director of the Gambling Control Unit has the
9 authority to administer and enforce the provisions of the Maine Revised Statutes, Title
10 17, chapter 13-A governing the conduct of beano and Title 17, chapter 62 governing
11 games of chance.

12 **PART JJJJJ**

13 This Part transfers the oversight, administration and enforcement of the Maine
14 Revised Statutes, Title 17, chapter 13-A governing beano from the Chief of the State
15 Police to the Gambling Control Unit within the Department of Public Safety. It reduces
16 some requirements for organizations that conduct beano, such as requiring them to
17 register with the Gambling Control Unit rather than apply for a license and to maintain
18 records of the use of proceeds from beano rather than regularly file disposition of funds
19 reports with the Gambling Control Unit. High-stakes beano under Title 17, chapter 13-A
20 is still subject to licensure. This Part also adds some provisions to Title 17, chapter 13-A
21 to permit schools, campgrounds and resorts to conduct beano for the entertainment of
22 their guests, including children under 16 years of age, as long as certain requirements are
23 met.

24 **PART KKKKK**

25 This Part transfers in the Department of Public Safety the oversight, administration
26 and enforcement of the Maine Revised Statutes, Title 17, chapter 62 governing games of
27 chance from a licensing unit to the Gambling Control Unit. It reduces some requirements
28 for organizations that conduct certain games of chance, such as requiring them to register
29 with the Gambling Control Unit rather than apply for a license and maintaining records of
30 the use of proceeds from games rather than regularly filing disposition of funds reports
31 with the Gambling Control Unit. Card games and most tournament games are still
32 subject to licensure under this Part. It adds a provision that permits the operation of
33 cribbage tournaments for charitable purposes without a license. These tournaments are
34 not required to be conducted by a nonprofit organization and may be conducted in places
35 like a restaurant or brewery tap room. Entry fees are limited to \$25, and all fees must be
36 paid as prizes or donated to a verifiable charitable purpose. It also makes changes
37 regarding the conduct of raffles for charitable purposes, including a provision that permits
38 the conduct of a raffle with a prize value up to \$1,000 to be conducted by a person or
39 organization without having to be licensed by or registered with the Gambling Control
40 Unit.

41 **PART LLLLL**

1 This Part provides that public safety inspectors in the Department of Public Safety,
2 Office of the State Fire Marshal for the purpose of enforcing the Maine Revised Statutes,
3 Title 25, section 2452, relating to statewide enforcement powers of the National Fire
4 Protection Association No. 101, Life Safety Code, have the right to execute or serve
5 criminal and civil violation process against offenders who violate the National Fire
6 Protection Association No. 101, Life Safety Code.

7 **PART MMMMM**

8 This Part amends the law regarding examinations of plans for construction,
9 reconstruction or repairs submitted to the Department of Public Safety by establishing a
10 single fee schedule for new construction, reconstruction, repairs and renovations of 1.5/10
11 of 1% of the cost to construct or reconstruct the portion of the project subject to State Fire
12 Marshal review.

13 **PART OOOOO**

14 This Part requires the State Controller to transfer \$1,000,000 in unexpended funds
15 from the Gambling Control Board program, Other Special Revenue Funds account in the
16 Department of Public Safety by the end of fiscal year 2018-19 to the General Fund
17 unappropriated surplus.

18 **PART PPPPP**

19 This Part increases the baseline appropriation for the Debt Service - UMS program
20 within the University of Maine System by \$3,000,000 per year starting in fiscal year
21 2019-20 for debt service costs to support a 10-year revenue bond for the construction of
22 an engineering building on the Orono campus of the University of Maine.

23 **PART QQQQQ**

24 This Part clarifies that there are 2 deputy commissioner positions within the
25 Department of Administrative and Financial Services. This Part also authorizes the
26 Commissioner of Administrative and Financial Services to reorganize the Bureau of
27 General Services and submit a bill in the Second Regular Session of the 128th Legislature
28 to enact the reorganization.

29 **PART RRRRR**

30 This Part requires the State Controller to transfer \$500,000 from General Fund
31 undedicated revenue annually to the Agriculture Promotion Fund in the Department of
32 Agriculture, Conservation and Forestry.

33 **PART SSSSS**

34 This Part provides the Commissioner of Corrections authority to inspect, review and
35 take custody of records of county jails related to the funding and operation of county jails.

36 This Part requires the Department of Corrections by February 15, 2018 to submit a
37 report to the Joint Standing Committee on Appropriations and Financial Affairs and the
38 Joint Standing Committee on Criminal Justice and Public Safety on plans to restructure
39 the funding and operation of county jails and correctional facilities and prisoner
40 population and capacity. The Joint Standing Committee on Criminal Justice and Public

1 Safety is authorized to report out legislation in the Second Regular Session of the 128th
2 Legislature implementing the recommendations.

3 **PART TTTTT**

4 This Part authorizes the University of Maine System to issue taxable bonds.

5 **PART VVVVV**

6 This Part provides for the creation of 9 to 12 school management and leadership
7 centers. School administrative units may voluntarily establish a school management and
8 leadership center through an interlocal agreement and may include associate members
9 through contractual agreements or memoranda of understanding. A school management
10 and leadership center provides administrative and education functions in accordance with
11 the interlocal agreement and functions as an extension of the schools that are members of
12 the school management and leadership center. Participating school administrative units
13 voluntarily choose which educational functions or support services they purchase from a
14 school management and leadership center.

15 **PART XXXXX**

16 Current law specifies that only 10 public charter schools may be approved. This Part
17 instead provides that no more than 10 public charter schools may operate at any one time.

18 **PART AAAAA**

19 This Part adds engaging in training and staff development for identification of and
20 provision of intervention services for children with autism to the program functions of the
21 Child Development Services System.

22 **PART EEEEE**

23 This Part directs the Department of Education to review the work of the
24 public-private partnership Count ME In and to undertake a comprehensive attendance
25 initiative to address truancy. This Part also directs the department to report to the Joint
26 Standing Committee on Education and Cultural Affairs by January 31, 2018.

27 **PART GGGGG**

28 This Part requires that any remaining balance in the Office of Substance Abuse and
29 Mental Health Services program, General Fund account within the Department of Health
30 and Human Services be carried forward for use by this program in the next fiscal year.

31 **PART IIIII**

32 This Part requires the Department of Health and Human Services to establish criteria
33 for a grant to be awarded to a provider of services that alert prescribers or dispensers to
34 the drug-related criminal background of patients and to award the grant to the applicant
35 most closely fitting those criteria.

36 **PART JJJJJ**

37 This Part authorizes the Department of Health and Human Services to transfer by
38 financial order available Personal Services line category balances in the Office for Family
39 Independence program and the Office for Family Independence - District program to the

1 All Other line category in either the Office for Family Independence program or the
2 Office for Family Independence - District program in order to provide funding for
3 information technology and related services.

4 **PART LLLLLL**

5 This Part directs the Commissioner of Agriculture, Conservation and Forestry to
6 adjust the fees for testing weighing and measuring devices so as to generate additional
7 undedicated revenue to the General Fund of \$100,000 annually, beginning in fiscal year
8 2017-18.

9 **PART PPPPPP**

10 This Part amends the duties of the position of Director of the Bureau of Parks and
11 Lands within the Department of Agriculture, Conservation and Forestry to specify that
12 the duties of the position may not be combined with any other position within the bureau
13 or department and that the position may not be filled in an acting capacity.

14 **PART SSSSSS**

15 This Part allows children of state employees to be eligible for the State Children's
16 Health Insurance Program as long as they meet the other eligibility requirements.

17 **PART TTTTTT**

18 This Part authorizes funding of the collective bargaining agreement reached by the
19 Judicial Department and 4 collective bargaining units.

20 **PART VVVVVV**

21 This Part provides a working capital advance of \$57,368 to the Board of
22 Complementary Health Care Providers from unobligated balances within the Licensing
23 and Enforcement program, Other Special Revenue Funds account from licensing,
24 registration and other fees of professions licensed, certified or registered within the
25 Department of Professional and Financial Regulation, Office of Professional and
26 Occupational Regulation by October 15, 2017 for the initial costs of establishing a new
27 licensing requirement for individuals practicing midwifery. It directs repayment of the
28 working capital advance from fees collected by the board no later than June 30, 2019.

29 **PART ZZZZZZ**

30 This Part makes appropriations and allocations necessary to carry out the purposes of
31 this amendment.

32 **PART AAAAAA**

33 This Part requires the Treasurer of State to first credit \$2,500,000 in fiscal year
34 2017-18 and \$2,500,000 in fiscal year 2018-19 of the revenues from the real estate
35 transfer tax that would have been deposited into the Housing Opportunities for Maine
36 Fund within the Maine State Housing Authority to the General Fund.

37 **PART BBBBBB**

38 This Part lapses \$2,500,000 from the Legislature, General Fund account to the
39 unappropriated surplus of the General fund in each year of the 2018-2019 biennium.

PART CCCCCC

This Part requires the State Controller to transfer from the Unclaimed Property Fund to the Maine Budget Stabilization Fund any amount in the Unclaimed Property Fund in excess of \$5,767,234 by June 30, 2017 and transfer \$2,000,000 from the Maine Budget Stabilization Fund to the General Fund unappropriated surplus by June 30, 2018.

PART DDDDDD

This Part requires the State Controller to lapse \$2,000,000 from the Education in Unorganized Territory, General Fund account in the Department of Education to the General Fund unappropriated surplus no later than June 30, 2018.

PART EEEEEEE

This Part authorizes the State Controller to transfer up to \$65,000,000 from the Maine Budget Stabilization Fund to a General Fund reserve account for the Department of Health and Human Services pending a notice and reconsideration of disallowance from the federal Centers for Medicare and Medicaid Services, dated June 7, 2017, related to the Riverview Psychiatric Center.

PART FFFFFFF

This Part requires the State Controller to carry any remaining balance in the Office of Treasurer of State, Debt Service program from fiscal year 2016-17 into fiscal year 2017-18 and from 2017-18 into 2018-19.

PART GGGGGGG

This Part requires the State Controller to carry forward into the following fiscal year for each year of the 2018-2019 biennium any remaining balance in the Fund for Efficient Delivery of Local and Regional Services program in the Department of Economic and Community Development.

PART HHHHHHH

This Part requires the State Controller to transfer \$11,200,000 from available balances in Other Special Revenue Funds accounts within the Department of Professional and Financial Regulation to the General Fund unappropriated surplus at the close of fiscal year 2017-18. The Commissioner of Professional and Financial Regulation is required to determine from which accounts the funds will be transferred so that the sum equals \$11,200,000 and notify the State Controller and the Joint Standing Committee on Appropriations and Financial Affairs of the amounts to be transferred from each account on or before June 30, 2018.

PART IIIIII

This Part requires the State Controller to transfer \$6,000,000 total from 2 court settlements reached by the State to the General Fund unappropriated surplus. The Attorney General has confirmed that the specified use of the funds to be transferred by this Part is consistent with the terms of the court orders.

PART JJJJJJ

1 This Part provides that if the budget of a school administrative unit is based on
2 assumptions that include an increase in the school administrative unit's state share of the
3 total cost of funding public education from kindergarten to grade 12 under the Essential
4 Programs and Services Funding Act, at least 50% of the increase in the state share of the
5 total cost of public education must be used to lower the local contributions to the total
6 cost of education and the remaining 50% may be used only if approved through an article
7 in the local budget to increase expenditures for school purposes in cost center categories
8 approved by the local board, increase the allocation of finances for a reserve fund or
9 provide an additional amount to lower the local contributions to the total cost of
10 education. For the school budget for fiscal year 2017-18 only, if the school budget
11 approved by the voters has earmarked additional state funding contributions for increased
12 expenditures for school purposes in fiscal year 2017-18, the use of the additional state
13 funding is permitted as approved.

14 **PART KKKKKKK**

15 This Part requires the State Controller to carry forward into the following fiscal year
16 for each year of the 2018-2019 biennium any remaining balance in the Debt Service -
17 Government Facilities Authority program.

18 **PART LLLLLLL**

19 This Part requires the State Controller to:

20 1. By June 30, 2018 and June 30, 2019, pay \$400,000 from the General Fund
21 unappropriated surplus to the Finance Authority of Maine to be deposited in the Doctors
22 for Maine's Future Scholarship Fund to provide funding for medical school scholarships
23 for eligible students;

24 2. By June 30, 2018 and June 30, 2019, transfer \$320,000 from the Board of
25 Licensure in Medicine, Department of Professional and Financial Regulation, Other
26 Special Revenue Funds account to the General Fund unappropriated surplus; and

27 3. By June 30, 2018 and June 30, 2019, transfer \$80,000 from the Board of
28 Osteopathic Licensure, Department of Professional and Financial Regulation, Other
29 Special Revenue Funds account to the General Fund unappropriated surplus.

30 **PART MMMMMM**

31 This Part requires the Department of Health and Human Services to increase the rates
32 for home-based and community-based personal care and related services referenced in the
33 February 1, 2016 report "Rate Review for Personal Care and Related Services: Final Rate
34 Models" prepared for the department by Burns & Associates, Inc. This Part also requires
35 the department to increase the rates for certain procedure codes provided in Chapter 101:
36 MaineCare Benefits Manual, Chapter III, Sections 21 and 29. The rates must be
37 increased on a proportionally equal basis using funding provided for that purpose
38 elsewhere in this legislation.

39 **PART NNNNNN**

40 This Part makes the following changes to the statutes relating to programs
41 administered by the Department of Health and Human Services.

- 1 1. It removes reference to the Aid to Families with Dependent Children, or AFDC,
2 program in the laws relating to electronic benefits transfer cards.
- 3 2. It makes changes to the laws relating to electronic benefits transfer cards by
4 allowing the department to place photographs on the cards and by restricting the number
5 of replacement cards issued.
- 6 3. It changes the statewide food supplement program eligibility requirements as they
7 relate to certain felons convicted of violent crimes and sexual assault and certain lottery
8 and gambling winners.
- 9 4. It provides for annual eligibility evaluations under the MaineCare program.
- 10 5. It changes the special housing allowance for families receiving TANF benefits to
11 provide the allowance to those whose shelter expenses exceed 50% of their monthly
12 income rather than 75% as in current law.
- 13 6. It provides for an increase in the monthly TANF maximum benefit. Beginning on
14 October 1, 2017, the maximum amount must be increased by 20% of the maximum
15 payments made on January 1, 2017. Beginning on October 1, 2018, the maximum
16 amount must be increased annually by an amount equal to the increase in the cost of
17 living pursuant to the federal supplemental security income program. The department is
18 directed to increase the standard of need to maintain the same differential between the
19 maximum payment and the standard of need that was in effect on January 1, 2017.
- 20 7. It directs the department, beginning in fiscal year 2017-18 and annually thereafter,
21 to provide \$3,000,000 in funds provided under the Temporary Assistance for Needy
22 Families block grant to the Maine State Housing Authority to provide heating assistance
23 for low-income families with children.
- 24 8. It allows the enrollment in the Parents as Scholars Program of a person pursuing
25 any degree or certification if the occupation has at least an average job outlook.
- 26 9. It requires reporting by the department on welfare fraud, provider contracts, grant
27 funding, department out-of-state travel costs and spending in the MaineCare program, the
28 TANF program, the statewide food supplement program and municipal general
29 assistance.
- 30 10. It establishes in the department a program to provide access to reliable,
31 affordable transportation for families receiving TANF benefits or benefits under the
32 Parents as Scholars Program or that are financially eligible for alternative aid in order to
33 allow them to obtain or retain sustainable employment.
- 34 11. Current law allows an individual to avoid being sanctioned for failure to
35 participate in the Additional Support for People in Retraining and Employment -
36 Temporary Assistance for Needy Families program, or ASPIRE-TANF program, if the
37 individual demonstrates good cause. The Part removes as evidence of good cause sexual
38 harassment at a program-approved component.
