

Fiscal Detail and Notes

This amendment removes the emergency clause and moves the one-time General Fund appropriation of \$50,000 from fiscal year 2016-17 to fiscal year 2017-18. The money is for the Maine State Library to provide mobile wireless hot spot devices to libraries in Washington County
