(3) The cost to construct the shell space may not exceed 15% of the cost of the approved project.

A hospital may not use shell space constructed pursuant to this paragraph without filing a subsequent application for a certificate of need pursuant to section 329, subsection 9.

Sec. 4. Rules. The Department of Health and Human Services shall provisionally adopt rules to implement the Maine Revised Statutes, Title 22, section 329, subsection 9 and section 335, subsection 8 no later than January 15, 2018. Rules adopted pursuant to this section are routine technical rules as defined in the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A.'

SUMMARY

12 This amendment is the minority report of the committee and makes the following 13 changes to the bill. It changes the title of the bill. It allows hospitals to construct shell 14 space if a hospital's application containing a request to increase bed capacity is granted 15 for a number of beds lower than the number requested and if the applicant proceeds with the approved project within the time frame required by the Maine Revised Statutes, Title 16 22, section 346. The amendment provides that the construction of shell space may not 17 18 exceed the square footage requested in the application, the square footage of the approved project by more than 15% and 15% of the cost of the approved project. The amendment 19 20 provides that in order for a hospital to use the shell space it must apply for another 21 certificate of need. It directs the Department of Health and Human Services to 22 provisionally adopt routine technical rules implementing these provisions no later than 23 January 15, 2018.
