11 12	Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:
13	'Sec. 1. 35-A MRSA §3144 is enacted to read:
14 15	<u>§3144. Mitigation measures to protect from geomagnetic disturbances and electromagnetic pulse</u>
16 17 18	Beginning December 1, 2017, and annually thereafter, the commission shall direct an investor-owned transmission and distribution utility to submit to the commission a report detailing what steps, if any, the investor-owned transmission and distribution utility has taken to protect its hulls teaconic or submit for a superscript distribution of the superscript of the supers
19 20	taken to protect its bulk transmission systems from geomagnetic disturbances and electromagnetic pulse, including activities undertaken to meet any federal
21 22	recommendations made to address geomagnetic disturbances and electromagnetic pulse. The commission shall require an investor-owned transmission and distribution utility to
22	include neutral direct current monitoring information from autotransformers where
24	monitoring equipment is installed, collected by the investor-owned transmission and
25	distribution utility. The commission, as part of its annual report pursuant to section 120
26 27	shall compile reports it has received pursuant to this section in the prior year and submit this information to the joint standing committee of the Legislature having jurisdiction
28	over utilities and energy matters.'
29	SUMMARY
30	This amendment is the majority report of the committee and it strikes and replaces
31	the bill. It requires an investor-owned transmission and distribution utility to report to the
32	Public Utilities Commission annually on its activities regarding protection from
33 34	geomagnetic disturbances and electromagnetic pulse. It also requires an investor-owned
34 35	transmission and distribution utility to include in its report the Public Utilities Commission neutral direct current monitoring information from autotransformers where

1 monitoring equipment is installed, collected by the investor-owned transmission and 2 distribution utility.
