12 13	Amend the bill by inserting after the title and before the enacting clause the following:
14 15	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
16 17 18	Whereas, current law allows a resident 70 years of age or older who has accumulated the necessary number of points to be awarded a moose hunting permit without participating in the public chance lottery for a moose permit; and
19 20	Whereas, many residents 70 years of age and older are unable to hunt moose at that age; and
21 22	Whereas, residents 65 years of age and older are better able to hunt moose if awarded a moose hunting permit; and
23 24	Whereas, this legislation must take effect before the end of the 90-day period so that it takes effect in time for the upcoming moose hunting season; and
25 26 27 28	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'
29	Amend the bill by adding before the summary the following:
30 31	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'
