COMMITTEE AMENDMENT "A" to H.P. 517, L.D. 737, Bill, "An Act To Allow Public Schools To Reserve Funds Designated for Operating Costs"

Amend the bill in section 2 in §1312-A in subsection 1 in the 2nd line (page 1, line 28 in L.D.) by inserting after the following: "and benefits" the following: ', by including a request in the district budget and receiving voter approval of a referendum at a district meeting or a district budget meeting'

Amend the bill in section 2 in §1312-A in subsection 3 in the 2nd line (page 1, line 36 in L.D.) by inserting after the following: "vote of the district" the following: 'voters on a referendum'

Amend the bill by inserting after section 2 the following:

'Sec. 3. 20-A MRSA §1352, sub-§2, ¶J is enacted to read:

J. When a referendum is called for the purposes of approving the establishment of a reserve fund for operating costs or expending the sum in the reserve fund as set forth in section 1312-A, the articles must be substantially as follows.

(1) "Shall the board of directors of School Administrative District No..... be authorized to establish a reserve fund for up to 3 months' operating costs, including salary and benefits?"

(2) "Shall the board of directors of School Administrative District No..... be authorized to expend the sum in the reserve fund for operating costs in an amount not to exceed \$....., which was voted by the district on (date)?"

This amendment is the majority report of the committee. The amendment adds a provision authorizing a school administrative district to establish a reserve fund for operating costs and to expend money from the reserve fund by including a request in the district budget and receiving voter approval of a referendum article at a district meeting or a district budget meeting.
