

1 **Be it enacted by the People of the State of Maine as follows:**

2 **PART A**

3 **Sec. A-1. 12 MRSA §12708, sub-§1, ¶B,** as amended by PL 2013, c. 408, §21,  
4 is further amended to read:

5 B. The following areas are classified as state-owned wildlife management areas, or  
6 "WMAs":

6 **Sec. A-3. 36 MRSA §4602, sub-§3, ¶D**, as repealed and replaced by PL 2001, c.  
7 164, §2, is amended to read:

8 D. District 4: Amity, Benedicta, Cary ~~Plantation~~ Township, Crystal, Dyer Brook,  
9 Hammond Plantation, Hershey, Hodgdon, Houlton, Island Falls, Linneus, Littleton,  
10 Ludlow, Merrill, Monticello, New Limerick, Oakfield, Patten, Sherman and Sherman  
11 Mills; and

12 **Sec. A-4. Effective date.** This Part takes effect July 1, 2018, if the legal voters of  
13 Cary Plantation approve the referendum under Part B, section 8.

## 14 **PART B**

15 **Sec. B-1. Deorganization of Cary Plantation.** Notwithstanding any contrary  
16 requirement of the Maine Revised Statutes, Title 30-A, chapter 302, if in accordance with  
17 Title 30-A, section 7207 a majority of the voters in Cary Plantation approve the  
18 deorganization procedure developed in accordance with Title 30-A, section 7205 and if  
19 the question of Cary Plantation's deorganization is approved by the registered voters of  
20 Cary Plantation pursuant to section 8 of this Part, Cary Plantation in Aroostook County is  
21 deorganized, except that the corporate existence, powers, duties and liabilities of the  
22 plantation survive for the purposes of prosecuting and defending all pending suits to  
23 which the plantation is, or may be, a party and all needful process arising out of any suits,  
24 including provisions for the payment of all or any judgments or debts that may be  
25 rendered against the plantation or exist in favor of any creditor.

26 **Sec. B-2. Financial obligations and other liabilities.** Any financial  
27 obligations or other liabilities that were incurred by Cary Plantation as a municipality or  
28 that were incurred by Cary Plantation as a member of School Administrative District No.  
29 70 or Regional School Unit No. 70 are excepted and reserved in accordance with the  
30 Maine Revised Statutes, Title 30-A, section 7303 and remain liabilities for the inhabitants  
31 of lawful age residing in the territory included in the deorganized Cary Township for the  
32 duration of the liabilities. The State Tax Assessor shall assess taxes against the property  
33 owners in the deorganized municipality of Cary Township to provide funds to satisfy any  
34 municipal or educational obligations or other liabilities. These financial obligations or  
35 other liabilities are not the responsibility of either the Department of Education or the  
36 taxpayers in the Unorganized Territory Tax District as described in Title 36, chapter 115.

37 **Sec. B-3. Deorganization procedure.** The deorganization of Cary Plantation  
38 must be conducted in accordance with the approved deorganization procedure developed  
39 in accordance with the Maine Revised Statutes, Title 30-A, section 7205 for the  
40 municipality.

1           **Sec. B-4. Unexpended school funds.** The treasurer of the plantation or any  
2 other person who has custody of the funds of the plantation shall pay the Treasurer of  
3 State all unexpended school funds that, together with the credits due the plantation for  
4 school purposes, are to be used by the State Tax Assessor to settle any school obligations  
5 incurred by the plantation before deorganization. The State Tax Assessor shall approve  
6 any written requests or invoices for payments and submit the approved documents to the  
7 fiscal administrator of the unorganized territory within the Office of the State Auditor to  
8 process through the Office of the State Controller. Any unexpended school funds  
9 remaining with the Treasurer of State after all the obligations have been met must be  
10 deposited to the Unorganized Territory Education and Services Fund, as directed in the  
11 Maine Revised Statutes, Title 36, chapter 115.

12           **Sec. B-5. Unexpended municipal funds and property.** The treasurer of the  
13 plantation or any other person who has custody of the funds of the plantation shall pay the  
14 Treasurer of State all unexpended funds of the plantation that, together with the credits  
15 due the plantation for its purposes, are to be used by the State Tax Assessor to settle any  
16 obligations of the plantation incurred by the plantation before deorganization. The State  
17 Tax Assessor shall approve any written requests or invoices for payments and shall  
18 submit the approved documents to the fiscal administrator of the unorganized territory  
19 within the Office of the State Auditor to process through the Office of the State  
20 Controller. Pursuant to the Maine Revised Statutes, Title 30-A, section 7304, at the end  
21 of a 5-year period during which the powers, duties and obligations relating to the affairs  
22 of the plantation are vested in the State Tax Assessor or when in the judgment of the State  
23 Tax Assessor final payment of all known obligations against the plantation has been  
24 made, any funds that have not been expended must be deposited with the county  
25 commissioners of Aroostook County as undedicated revenue for the unorganized territory  
26 fund of that county.

27           Any property of the plantation that has not been sold must be held by the State in  
28 trust for the unorganized territory or transferred to Aroostook County to be held in trust  
29 for the unorganized territory. Income from the use or sale of that property held by the  
30 State must be credited to or deposited in the Unorganized Territory Education and  
31 Services Fund under Title 36, chapter 115. Income from the use or sale of that property  
32 held by Aroostook County must be credited to the unorganized territory fund of the  
33 county pursuant to Title 36, section 1604, subsection 4.

34           **Sec. B-6. Provision of education services.** Notwithstanding any other law,  
35 education in the unorganized territory of Cary Township must be provided under the  
36 direction of the Commissioner of Education as described in the Maine Revised Statutes,  
37 Title 20-A, chapter 119 and must meet the general standards for elementary and  
38 secondary schooling and special education established pursuant to Title 20-A. The  
39 provisions described in subsections 1 to 3 must be implemented at the time of  
40 deorganization.

41           1. Students in prekindergarten to grade 12 whose parents or legal guardians are legal  
42 residents of the unorganized territory of Cary Township must be provided educational  
43 services at Regional School Unit No. 70 school facilities located in the Town of

1 Hodgdon. Transportation services to and from school must be provided under the  
2 direction of the Department of Education.

3 2. Special education services must be provided to eligible resident students as  
4 required by federal and state laws, rules and regulations.

5 3. Career and technical education must be provided to eligible resident students  
6 pursuant to Title 20-A, section 3253-A.

7 Tuition to schools other than those identified in this section may be provided on  
8 behalf of resident students with the prior approval of the director of state schools within  
9 the Department of Education. Tuition payments may not exceed the limits established in  
10 Title 20-A, section 3304 and transportation is the responsibility of the parents or legal  
11 guardians. The receiving school must be approved by the Commissioner of Education for  
12 the purpose of tuition.

13 The provision of educational services in this section is subject to modification in  
14 response to educational conditions.

15 **Sec. B-7. Assessment of taxes.** The State Tax Assessor shall assess the real and  
16 personal property taxes in Cary Plantation as of April 1, 2018, as provided in the Maine  
17 Revised Statutes, Title 36, section 1602.

18 **Sec. B-8. Referendum; certificate to Secretary of State.** This Part takes  
19 effect 90 days after its approval only for the purpose of permitting its submission by the  
20 municipal officers to the legal voters of Cary Plantation by ballot at the next statewide  
21 election held in the month of November. This election must be called, advertised and  
22 conducted according to the Maine Revised Statutes, Title 30-A, sections 2528 and 2532.  
23 The Cary Plantation clerk shall prepare the required ballots on which the clerk shall  
24 reduce the subject matter of this Part to the following question:

25 "Shall Cary Plantation be deorganized?"

26 The voters shall indicate their opinion on this question by a cross or check mark  
27 placed against the word "Yes" or "No." Before becoming effective, the question posed  
28 to voters must be approved by at least 2/3 of the legal voters casting ballots during the  
29 statewide election, and the total number of votes that are cast for and against the  
30 deorganization in the election must equal or exceed 50% of the total number of votes cast  
31 in the plantation for Governor at the last gubernatorial election.

32 The municipal officers of Cary Plantation shall declare the result of the vote. The  
33 clerk of Cary Plantation shall file a certificate of the election result with the Secretary of  
34 State within 10 days from the date of the election.

35 **Sec. B-9. Effective date.** Sections 1 to 7 of this Part take effect July 1, 2018 if the  
36 legal voters of Cary Plantation approve the referendum under section 8 of this Part.

**PART C**

**Sec. C-1. Register and transmit copy of approved deorganization procedure.** Before the effective date of the deorganization of Cary Plantation pursuant to Part B, the fiscal administrator of the unorganized territory within the Office of the State Auditor shall transmit a copy of the approved deorganization procedure developed in accordance with the Maine Revised Statutes, Title 30-A, section 7205 to the Aroostook County administrator, and shall register the approved deorganization procedure with the Aroostook County Registry of Deeds.

**Sec. C-2. Effective date.** This Part takes effect upon approval of the referendum under Part B, section 8.

**SUMMARY**

This bill provides for the deorganization of Cary Plantation in Aroostook County, subject to approval at local referendum.
