COMMITTEE AMENDMENT "A" to S.P. 257, L.D. 812, "Resolve, To Establish a Pilot Project To Save Lives and Support People with Substance Use Disorder in Washington County"

Amend the resolve by striking out everything after the title and before the summary and inserting the following:

Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, substance use disorder is a crisis in Washington County requiring a systems approach to combat the issue; and

Whereas, a pilot project in Washington County developed without the need for state general funds must be evaluated and provide data allowing for replication in other rural areas of the State; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Washington County Substance Use Disorder Pilot Project established. Resolved: That the Department of Health and Human Services shall establish a Washington County Substance Use Disorder Pilot Project, referred to in this resolve as "the pilot project," to develop a systems approach to providing services in a rural area for residents of Washington County with substance use disorder through helping to coordinate service needs among organizations and providers to help bridge any gaps in services and ultimately assisting individuals in accessing treatment and recovery services when they are ready. The department shall work with Healthy Acadia as the lead agency in Washington County for developing the pilot project. The department shall provide advice and assistance to Healthy Acadia in applying for federal grant funding from the United States Department of Health and Human Services, Substance Abuse and

1 Mental Health Services Administration to fund the pilot project, including any requests
2 for proposals required by this resolve; and be it further

3 **Sec. 2. Telephone system. Resolved:** That the Department of Health and
4 Human Services shall work with Healthy Acadia to establish a central coordinating
5 telephone system located in Washington County no later than October 1, 2018. The
6 department may expand an existing hotline or use some other strategy to establish the
7 telephone system. The telephone system must be staffed at all times so that it is available
8 at any time to any person in Washington County. The telephone system must be made
9 widely available to organizations in Washington County, including law enforcement,
10 medical and emergency personnel, public officials, educational staff and members of the
11 public, to connect those in need of substance use disorder treatment with counseling,
12 referral services, recovery coaches and other related assistance. Telephone system staff
13 answering the telephone calls must be qualified to provide counseling in addition to
14 referral services. The department and the coordinating council established pursuant to
15 section 3 shall develop a system that coordinates the Washington County telephone
16 system with the State's 2-1-1 system to ensure maximum access for any person who calls
17 the telephone system; and be it further

18 **Sec. 3. Washington County Coordinating Council. Resolved:** That the
19 Department of Health and Human Services shall work with Healthy Acadia to establish
20 and support a Washington County Coordinating Council consisting of up to 15 members
21 representing persons and organizations in Washington County and surrounding areas
22 involved in substance use disorder prevention, treatment and recovery, including a
23 representative from Healthy Acadia as lead agency; a representative from the Department
24 of Health and Human Services; members of organizations representing health care,
25 including primary care, emergency care, hospitals, mental health agencies and providers
26 of substance use disorder treatment, including faith-based treatment; members of law
27 enforcement, including county jails; organizations involved in education, prevention and
28 advocacy; a person involved in the local business community; and persons in recovery
29 living in the area. The council shall choose a chair to preside over meetings and it shall
30 meet at least once every 2 months. The Department of Health and Human Services shall
31 work with Healthy Acadia to ensure that an executive assistant coordinates record
32 keeping and meetings and other administrative tasks. The council shall coordinate
33 services in the pilot project, including access to the telephone system established pursuant
34 to section 2 and accuracy of information relating to services, medication-assisted
35 treatment, detoxification, residential and other treatment services, peer recovery and
36 coaching services, education programs in schools, pain and chronic disease self-
37 management classes, jail treatment programs and other programs as well as tracking
38 barriers to treatment and recovery and facilitating system improvements to reduce or
39 eliminate identified barriers; and be it further

40 **Sec. 4. Recovery coaching. Resolved:** That the Department of Health and
41 Human Services shall establish and support recovery coaching services in Washington
42 County. A coordinator shall assist in developing, training and establishing recovery
43 coaches who provide volunteer services around Washington County, including ensuring
44 that recovery coaches are connected to persons in treatment and recovery, including
45 through the telephone system established pursuant to section 2, and that recovery coaches
46 are available at all times, and in keeping track of the system of recovery coaches. The

1 department and coordinator shall endeavor to provide assistance to volunteers such as
2 recruiting, training, transportation assistance, facilitating connections to community
3 organizations and other assistance; and be it further

4 **Sec. 5. Evaluation program. Resolved:** That by June 30, 2019 the Department
5 of Health and Human Services shall establish and report baseline and recovery outcome
6 measures to be used in evaluating the pilot project. To the extent required and supported
7 by federal grant funding, the department shall conduct an evaluation of the pilot project.
8 The department, in conjunction with the coordinating council established pursuant to
9 section 3, shall report the findings of the evaluation to the joint standing committee of the
10 Legislature having jurisdiction over health and human services matters no later than
11 March 1, 2021. The committee may report out legislation related to the report to the First
12 Regular Session of the 130th Legislature.

13 **Emergency clause.** In view of the emergency cited in the preamble, this
14 legislation takes effect when approved.'

15 **SUMMARY**

16 This amendment replaces the resolve. It amends the proposed Washington County
17 Substance Use Disorder Pilot Project in the following ways.

18 1. It establishes the pilot project under the Department of Health and Human
19 Services working with local organizations, with Healthy Acadia as the lead organization.
20 The department is required to assist Healthy Acadia with seeking federal funding for the
21 pilot project.

22 2. It requires the establishment of a central coordinating telephone system available
23 to anyone in Washington County at any time to assist individuals with accessing services
24 related to substance use disorder treatment and recovery. Individuals receiving the phone
25 calls must be qualified to provide counseling services to all callers in addition to
26 providing referrals.

27 3. It requires the establishment of a coordinating council made up of representatives
28 of persons and organizations in the area involved in the health and welfare of Washington
29 County residents. The council is responsible for providing a coordinated system of
30 services for prevention, treatment and recovery for substance use disorder.

31 4. It requires the establishment of a recovery coach coordinator position. The
32 coordinator is required to establish a system of recovery coaches available in all areas of
33 the treatment and recovery system in Washington County and provide education and
34 support to volunteer recovery coaches.

35 5. It requires the Department of Health and Human Services to conduct an evaluation
36 of the success of the pilot project in Washington County. The department must report to
37 the joint standing committee of the Legislature having jurisdiction over health and human
38 services matters on the evaluation no later than March 1, 2021.

Fiscal Detail and Notes

The bill establishes a pilot project under the Department of Health and Human Services (DHHS) working with local organizations with Healthy Acadia as the lead organization. It establishes a central coordinating telephone system available to anyone in Washington County at any time to assist individuals with accessing services related to substance use disorder treatment and recovery services. Additionally, it establishes a coordinating council responsible for providing a coordinated system of services for prevention and treatment of, and recovery from, substance use disorder. It also establishes a recovery coach coordinator position to be supported by DHHS. The bill requires the DHHS to conduct an evaluation of the success of the pilot project in Washington County, if federal funding is available. Finally, it requires the DHHS to advise and provide assistance to Healthy Acadia in applying for federal grant funding from the Substance Abuse and Mental Health Services Administration to fund the pilot project, including any requests for proposals required by the bill. This is all to be done without requiring state general fund dollars. It is expected that provisions of this bill will require additional federal funding.
