**An Act To Adopt Tiny House Standards in the Maine Uniform
Building and Energy Code**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 10 MRSA §9721, sub-§5** is enacted to read:

3 **5. Tiny house.** "Tiny house" means a dwelling that is less than 400 square feet in
4 floor area, excluding the area of any floor level located above the main floor.

5 **Sec. 2. 10 MRSA §9722, sub-§6, ¶J,** as amended by PL 2011, c. 365, §1 and c.
6 408, §2, is further amended to read:

7 J. In the adoption and amendment of the Maine Uniform Building and Energy Code,
8 ensure that nontraditional or experimental construction, including but not limited to
9 straw bale and earth berm construction and tiny house construction, is permissible
10 under the code;

11 **Sec. 3. Standards for tiny house construction.** No later than January 1, 2018,
12 the Technical Building Codes and Standards Board shall adopt standards for tiny house
13 construction consistent with the Tiny House Appendix to the International Residential
14 Code, RB 168-16, Appendix V, as approved by the International Code Council in
15 December 2016. The adoption of standards pursuant to this section is considered routine
16 technical rulemaking under the Maine Revised Statutes, Title 5, chapter 375, subchapter
17 2-A.

18 **SUMMARY**

19 This bill requires the Technical Building Codes and Standards Board to ensure that
20 tiny house construction is permissible under the Maine Uniform Building and Energy
21 Code. The bill also requires that the Technical Building Codes and Standards Board adopt
22 standards for tiny house construction consistent with the Tiny House Appendix to the
23 International Residential Code, as approved by the International Code Council in
24 December 2016.
